



4. First, build the rule making's Preamble:

From the Preamble menu button, select the appropriate preamble for the rule-making type:




Click in the yellow macrobuttons and replace the text as applicable for the rule making:



 Next, create the Item statements and amendments. Use the Adopt New, Amend, Rescind or Renumber menu button, as applicable, to create each Item statement. *For Adopted and Filed or Adopted and Filed Emergency After Notice rule makings, please see <u>paragraph "5"</u> below.

Adopt New

Use the "Adopt New" button to create an Item statement to adopt a <u>new</u> chapter, rule or subpart of a rule. (If replacing an existing chapter, rule, or subpart of a rule with a new one, use the "rescind and adopt new" statements under the Rescind button instead (see instruction below).)




Click in the yellow macrobuttons in the Item statement to insert the Item number and, for purposes of this example, the new rule number. Use the generated framework to number and draft the new rule. Because the entire rule is new, there is no need to underscore the text. Copy the formatting to expand any paragraph fields as necessary. Delete any extraneous fields.

Amend

Use the "Amend" button to create an Item statement to amend an existing chapter, rule or rule subpart:

Fill in the fields of the dialog box, and click OK to insert the text from the IAC. Except when amending an entire chapter, use the rule as the basis for the amendment. If the amendment applies only to a rule subpart, such as a subrule in the case of this example, retain the subpart to be amended and delete the rest of the rule.


Use the <u>underscore</u> and strikethrough formatting tools (do **not** use Track Changes) to amend the text as needed.

Rescind

Use the "Rescind" button to create an Item statement to rescind; to rescind and reserve (to avoid the need for renumbering or relettering subsequent chapters, rules, paragraphs, etc.) an existing chapter, rule, or rule subpart; or to rescind an existing chapter, rule, or rule subpart and adopt a <u>new</u> one in lieu thereof.

Click in the Item statement to insert the Item number and, for purposes of this example, the rule number. For a "rescind and adopt new" Item, use the generated framework to number and draft the new chapter, rule or rule subpart.



Renumber

Use the "Renumber" button to create an Item statement to renumber or reletter an existing rule or rule subpart. Renumbering an existing rule or rule subpart can allow space for new material to be inserted in sequence or to "close" space created as a result of rescission of material in a sequence.

Click in the Item statement to insert the Item number and the rule or rule subpart(s) to be renumbered. Note that this menu may also be used to amend renumbered rules and rule subparts.

- 6. For an Adopted and Filed rule making, after you have created the preamble, select the "Open ARC Document" menu button and enter the ARC number of the related Notice of Intended Action. Then, rather than recreate the amendments, copy them from the edited and published Notice and paste them into the Adopted and Filed rule making. If there are changes from the Notice in response to public comment or agency review, make the necessary changes to the amendments and describe the changes in the preamble. You may also copy the preamble of the published Notice and tailor it to serve as the preamble of your Adopted and Filed rule making.
- 7. After the document is complete, carefully review its content and format to ensure that:
 - The dates (e.g., date of hearing, effective date) and citations in the preamble are accurate and consistent with statutory requirements.
 - Any amendment of text from the IAC has been made to the most recent version of that text (*be sure no amendments have been made to the affected text since the document was drafted*).
 - That striking and underscoring, not Track Changes, was used to amend existing text.
 - All paragraphs are double spaced and indented properly. To avoid problems with paragraph numbering and indentation, do not use Auto-numbering.
- 8. Save your document in an editable format (i.e., .rtf, .doc or .docx), and refer to the content in your document's preamble to fill in the required fields on the RMS filing form. The summary paragraphs in the preamble can be copied and pasted into the filing form. Submit your document through RMS. Do not submit a PDF.
