Electrical Examining Board

For the 2023 reporting period, there were fourteen (14) veterans who requested credit for military electrical training in their application for licensing as an electrician, and nine (9) of the applicants were granted license. Thirty one (31) veterans requested reciprocity and nineteen (19) qualified for licensure and were licensed. According to Electrical Examining Board data, there are approximately 1,427 active electricians who are veterans.
