
## City Consolidated Property Tax Rates — FY 2022

## Average for Cities



Note: Only cities with a population over 10,000 are shown on the map. The top 10 includes all cities, regardless of population. The consolidated property tax rate is the aggregate of property tax levied within the city, divided by the total taxable valuation (with gas, electric, and water utilities) within the city, with the result multiplied by \$1,000. Agricultural property located within cities is not included in the average consolidated rate calculation. Urban property that is exempt from the city tax rate is not included.
