EXECUTIVE SUMMARY

AGRICULTURE AND NATURAL RESOURCES APPROPRIATIONS BILL

FUNDING SUMMARY

General Fund FY 2025: Appropriates a total of \$44.6 million from the General Fund and 1,617.0 full-time equivalent (FTE) positions for FY 2025. This is an increase of \$1.0 million and an increase of 203.0 FTE positions compared to estimated FY 2024.

The General Fund changes include:

- An increase of \$472,000 to the Department of Agriculture and Land Stewardship (DALSA) Administrative Division.
- An increase of \$557,000 to Department of Natural Resources (DNR) Operations.

Other Funds FY 2025: Appropriates a total of \$96.4 million from other funds. This is no change compared to estimated FY 2024. This Bill appropriates \$49.8 million from the Fish and Wildlife Trust Fund, \$42.0 million from the Environment First Fund (EFF), \$3.5 million from the Groundwater Protection Fund (GWPF), and \$1.2 million from various other funds.

Iowa Code section [8.57A](#) contains a standing appropriation of \$42.0 million from the Rebuild Iowa Infrastructure Fund (RIIF) to the EFF, and this Bill appropriates the the following amounts to the following departments for FY 2024:

- \$17.3 million to the DALSA.
- \$24.0 million to the DNR.
- \$695,000 to the University of Iowa (UI).

This Bill appropriates \$12.0 million from the EFF to the Resource Enhancement and Protection (REAP) Fund in lieu of the \$20.0 million General Fund standing appropriation in Iowa Code chapter [455A](#) and allocates \$1.0 million from the Open Spaces Account of the REAP to be used for State park maintenance, repair, and refurbishment for FY 2025. This Bill also appropriates \$375,000 for the Floodplain Management and Dam Safety Program in addition to a \$1.5 million appropriation from the General Fund.

MAJOR INCREASES/DECREASES/TRANSFERS OF EXISTING PROGRAMS

General Fund — DALSA Administrative Division: Appropriates a total of \$19.7 million and 420.0 FTE positions from the General Fund for FY 2025. This is an increase of \$472,000 and 81.8 FTE positions compared to estimated FY 2024.

General Fund — DNR Operations: Appropriates a total of \$12.5 million and 1,146.0 FTE positions from the General Fund for FY 2025. This is an increase of \$557,000 and 120.3 FTE positions compared to

FUNDING FOR PROJECTS AND PROGRAMS

Appropriates \$1.7 million from the General Fund to the Choose Iowa Fund. From the Fund, \$475,000 must be used for the Value Added Agricultural Grant Program and up to \$750,000 may be used for the Dairy Innovation and Revitalization Program.

This appropriation is contingent on the enactment of 2024 Iowa Acts, [SF 2410](#) (Department of Agriculture Programs and Activities Bill), or successor legislation.

In addition, the Program funds special projects in local food markets.

5 10 b. Not more than 10 percent of the moneys appropriated

Prohibits the use of more than 10.00% of the funds appropriated to the Southern Iowa Development and Conservation Fund for administration.

General Fund appropriation to the DALs for the administration and enforcement of grain dealer regulation and agricultural product warehouses.

DETAIL: Maintains the current level of funding compared to estimated FY 2024. The program was first funded in FY 2021 with the enactment of [HF 2643](#) (FY 2021 Omnibus Appropriations Act).

 5 28 salaries, support, maintenance, and miscellaneous purposes; and
 5 29 for not more than the following full-time equivalent positions:
 5 30 \$ 12,479,695

5 32 2. Of the number of full-time equivalent positions
 5 33 authorized to the department pursuant to subsection 1, 50.00
 5 34 full-time equivalent positions shall be allocated by the

Requires the DNR to allocate 50.00 FTE positions to State park operations for seasonal maintenance and upkeep. This does not affect the number of Conservation Officer, Park Ranger, or Park Manager FTE positions.

6 4 3. The department shall submit a report each quarter of
6 5 the fiscal year to the general assembly and the department

Requires the DNR to submit a quarterly report to the General Assembly and the DOM detailing the expenditure of moneys appropriated for DNR administration, regulation, and programs.

State Fish and Game Protection Fund appropriation to the law enforcement, fisheries, and wildlife programs of the DNR.

DETAIL: Maintains the current level of funding compared to estimated FY 2024. The allocations include:

- \$100,303 for the Storage Tanks Program. The funds are used for the administration of the State Underground Storage Tank (UST) Program.
- \$447,324 for the Household Hazardous Waste Program. The funds are allocated to regional collection centers and for administration of the Program.
- \$62,461 for administration of the Private Well Testing Program. The funds are used by the DNR for administering the closure of private wells.
- \$1,686,751 for groundwater monitoring. The funds are used for monitoring groundwater at sanitary disposal projects.
- \$618,993 for the Landfill Alternatives Program. The Program is now called the Solid Waste Alternatives Program (SWAP), and the funds are used to provide financial assistance to local governments; public and private groups, businesses, and individuals for education; market development projects; and utilization of best practices to reduce landfill waste.
- \$192,500 for the Waste Reduction and Assistance Program. The Program is now called the Pollution Prevention Services Program and provides confidential and nonregulatory assistance to facility operators.
- \$50,000 to administer the SWAP.
- \$297,518 for the Geographic Information System (GIS) Program. The funds are used to maintain the GIS and a comprehensive water resource data system that can be used by the public.
