

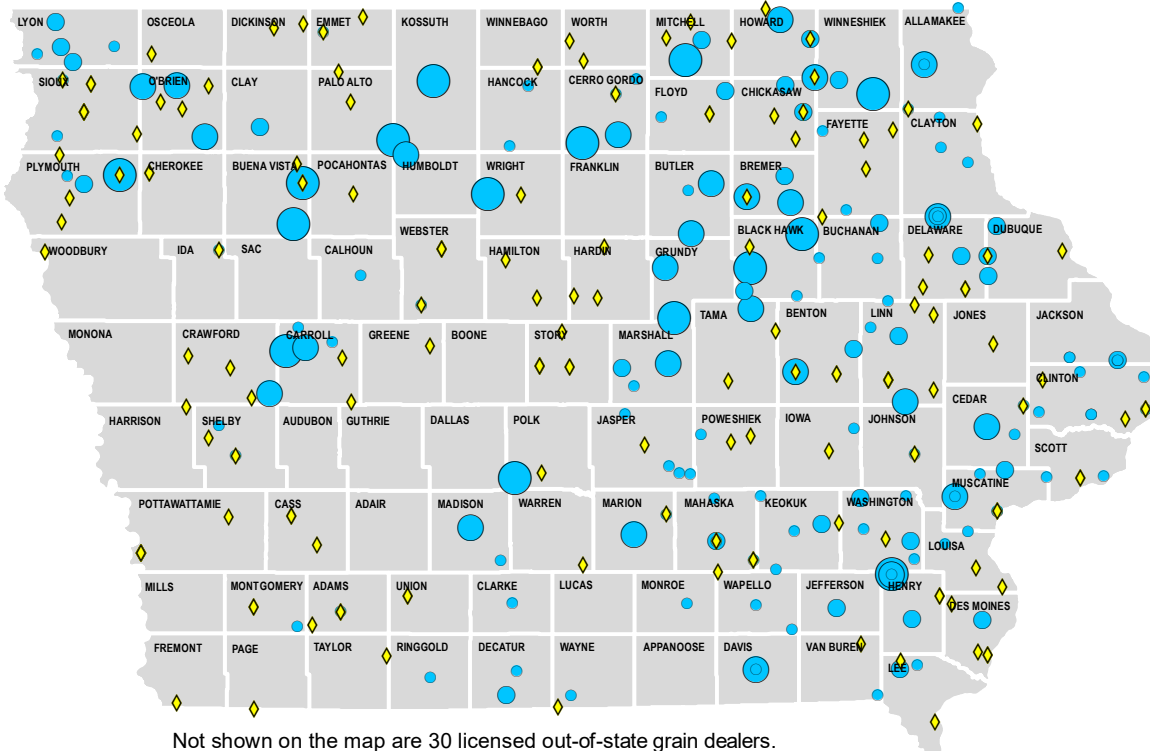
Licensed Iowa Grain Warehouses and the Grain Indemnity Fund — FY 2018

The Iowa Department of Agriculture and Land Stewardship (IDALS) establishes licensing procedures for warehouse operators who accept bulk grain for storage and for commercial buyers of grain. These procedures are set forth in [Iowa Code chapter 203C](#).

Licensed warehouse operators and grain dealers are required to participate in the Grain Indemnity Fund by paying an annual participation fee and a per-bushel fee on all purchased grain. The Fund covers a portion of the loss if a warehouse or grain dealer failure occurs.
