Iowa State Industries Revolving Fund

Purpose

The purpose of Iowa State Industries, also referred to as Iowa Prison Industries (IPI), is to provide work training opportunities for inmates. IPI oversees traditional Industries' programs, private sector employment, and the prison farms. IPI is self-funded and operates without General Fund support. Products are only available for purchase by government agencies and employees of these agencies, school districts and employees of school districts, and nonprofit organizations. The vision of IPI is to provide meaningful work training opportunities to develop utilizable skills for every person, and its mission is to be a self-sufficient program that positively impacts participant lives, reduces recidivism, and provides valued products and services to Iowa's communities.

Fund Created

lowa Code section <u>904.813</u> creates the lowa State Industries Revolving Fund to maintain and operate IPI work programs. Receipts from the sale of products are deposited in the Fund. Expenditures include operating costs, such as direct payments to vendors for the purchase of raw materials and capital equipment used in manufacturing processes; wages and benefits of IPI staff; stipends paid to offenders; and per diem and expenses of the lowa Prison Industries Advisory Board. The year-end balance carries forward to the next fiscal year and interest earned on the balance remains in the Fund. Prison farm operation receipts and expenses are not included in the Industries Revolving Fund, but kept in the Revolving Farm Fund created in lowa Code section <u>904.706</u>.

Traditional Prison Industries

IPI includes the following programs at the institutions:

- Anamosa State Penitentiary: Braille transcription, filters, chemicals, printing, license tags, signs, and plastics. This institution also has the business office for IPI.
- Iowa State Penitentiary at Fort Madison: Textiles.
- Newton Correctional Facility: Home building and centralized canteen. The canteen is governed by lowa Code section <u>904.310</u>.
- Iowa Correctional Institution for Women at Mitchellville: Compact disc (CD) archiving, textiles, embroidery, and garment printing.
- North Central Correctional Facility at Rockwell City: Welding, assembly, and painting.

Private Sector Employment

Private sector employment of inmates is managed by IPI in compliance with federal and State law (Iowa Code section <u>904.809</u>). Iowa Workforce Development establishes the prevailing wage that inmates must be paid. Private sector employment is available at the following locations:

- Iowa Correctional Institution for Women at Mitchellville: Sewing, packaging, and assembly.
- Clarinda Correctional Facility: Cargo trailers.
- North Central Correctional Facility at Rockwell City: Packaging and metal products.
- Fort Dodge Correctional Facility: Sewing and packaging.
- Mount Pleasant Correctional Facility: Packaging and assembly.
