# Employment Appeal Board — Department of Inspections and Appeals

### Description

The authority and duties of the Employment Appeal Board are specified in Iowa Code section 10A.601. The Board is administratively attached to the Department of Inspections and Appeals (DIA). It is a three-member Board, appointed by the Governor and confirmed by the Senate, that serves as the final administrative law forum for appeals. Board members are selected to represent employers, employees, and the general public. The Board has authority to hear appeals for the following:

- Personnel actions under lowa Code chapter 8A.
- Peace officer and Capitol security discharges under lowa Code chapter 80.
- Occupational Safety and Health Act citations under Iowa Code chapter 88.
- Construction contractor registration citations under lowa Code chapter 91C.
- Unemployment insurance appeals under lowa Code chapter 96.
- Iowa Public Employees' Retirement System (IPERS) appeals under Iowa Code chapter 97B.

#### **Funding**

The Employment Appeal Board receives an annual General Fund appropriation.
