# TEMPORARY LAWS

OF THE

### STATE OF IOWA.

PASSED AT THE REGULAR SESSION THEREOF, HELD AT DES MOINES, THE CAPITAL OF THE STATE, BEGUN ON THE TWELFTH DAY OF JANUARY, AND ENDED ON THE NINETEENTH DAY OF MARCH, A. D. MDCCCLXXIV.

#### CHAPTER I.

EXPENSES OF TEMPORARY ORGANIZATION OF THE GENERAL ASSEMBLY.

AN ACT Making an Appropriation for the Payment of Mileage of the S. F. 45. Members of the Fifteenth General Assembly, and the per diem of the temporary Officers and Employees thereof.

Section 1. Be it enacted by the General Assembly of the Appropria-State of Iowa, That the following sums of money, or so much thereof as may be necessary, are hereby appropriated for the purposes hereinafter designated.

Suc. 2. For the payment of the mileage of the members of Mileage; senthe senate, including ex-Lieutenant-Governor Bulis, and Lieutenant-Governor Dysart, the sum of two thousand six hundred and twenty-three dollars.

Sec. 3. For the payment of the mileage of the members of H. R., \$5600, the house of representatives, the sum of five thousand six hundred dollars, or as much thereof as will be necessary for the payment of the same.

Sec. 4. For the payment of the per diem of ex-Lieutenant-Pay of tem-Governor Bulis, for seventeen days' services as president of the Porary officers of senate during the temporary organization of the Fifteenth Gen-Postdent, eral Assembly, the sum of one hundred and seventy dollars.

SEC. 19. To Henry Morggridge, for thirteen days' services as temporary assistant janitor for the house of representatives, fiftytwo dollars.

To A. Reel, for thirteen days' services as temporary SEC. 20. messenger for the house of representatives, twenty-six dollars.

SEC. 21. To Wilson Reed and Herbert Wood, each twelve days' services as temporary messengers for the house of representatives, forty-eight dollars.

SEC. 22. To C. S. Mores [Mooers] and A. A. Smith, each Paper-folders, twelve days as temporary paper-folders for the house of representatives, forty-eight dollars.

For expenses incurred by inauguration ceremonies, Inauguration, the sum of two hundred dollars, or so much thereof as may be necessary, ordered to be drawn in favor of Senator Pease, chairman of joint committee on inauguration ceremonies.

The auditor of state shall issue warrants upon the state treasurer for the foregoing sums, in favor of the members of the respective houses, and deliver the same to the state treasurer.

Sec. 25. The treasurer of state, upon receipt of said warrants, Treasurer of shall pay to each member such amount as shall be shown to be how. his due by the reports of the committees on mileage, as adopted by each house respectively, and it is hereby made the duty of the president and secretary of the senate, and the speaker and clerk of the house, to furnish the treasurer of state certified copies of said reports so adopted by their respective houses.

SEC. 26. This bill being deemed of immediate importance Publication. shall take effect and be in force immediately after its publication in The Iowa State Register and State Journal, papers published at Des Moines, Iowa, anything in the statutes to the contrary notwith-

standing.

#### CHAPTER II.

#### NOTARIAL ACTS OF JOHN HOSFORD LEGALIZED.

AN ACT to Legalize the official Acts of John Hosford, a Notary Public S. F. 55. of Fayette county, Iowa.

WHEREAS, John Hosford of Fayette county, Iowa, was appreamble. pointed notary public January 15th, 1872, and performed official acts before having his commission properly recorded; therefore,

SECTION 1. Be it enacted by the General Assembly of the Acts legalized, State of Iowa, That all of the official acts of the said John Hosford are hereby legalized and made valid and of same force and effect as they would have been had his commission been recorded prior to the performance of said acts.

SEC. 2. This act shall be in force twenty days after publica- Publication. tion in The Iowa State Register, Des Moines, and The People s Paper, Claremont [Clermont], without expense to the state.
