Second—The total number of miles in each separate line or division thereof, together with the number of separate wires thereon, and stating the counties through which the same is carried. Third—The total number of telegraph stations on each separate line, and the total number of telegraphic instruments in use therein, together with the total number of

stations, other than railroad stations, maintained. Fourth—The average number of telegraph poles, per mile, used in the construction and maintenance of said lines.
