D. 1888 and entitled "An act to amend chapter 181 of the acts of the Twenty First General Assembly, relating to elections held within cities and to registration of voters therein" and said election was held in conformity to said latter act except as hereinbefore stated; and

WHEREAS, Doubts have arisen as to the legality of said registration and said election held as aforesaid; therefore Doubts as to legality.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That said registration and election be and the same is hereby ratified and declared to be and remain of full force and validity. Registration and election legalized.

CHAPTER 159.

LEGALIZING INCORPORATION AND ORDINANCES OF TOWN OF ACKWORTH.

AN ACT to Legalize the Incorporation of the town of Ackworth in Warren County, Iowa; to Legalize the Ordinances of the Town Council of Said Town, and to Legalize the Acts of the Officers of Said Incorporated Town Under the Ordinances of Said Town. H. F. 530.

WHEREAS, The council of the incorporated town of Ackworth in Warren County, Iowa, has heretofore levied certain taxes; and Taxes levied.

WHEREAS, The mayor of said incorporated town has heretofore imposed fines for a violation of the ordinances of said town and of the State of Iowa; and, Fines.

WHEREAS, Said taxes so levied, and said fines so imposed were prior to the filing of the notices, proceedings and records therein—with the Secretary of State; and,

WHEREAS, Doubts have arisen as to the legality of the incorporation of said town of Ackworth, and of the ordinances of the town council of said town, and the acts of the mayors of said town under the ordinances so passed; therefore Doubts as to legality.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That all said proceedings of the town of Ackworth, in Warren county, Iowa, in relation to the incorporation thereof—all ordinances of the town council of said incorporated town, so far as the same are not inconsistent with the laws of Iowa, and all acts of the officers of said incorporated town under the ordinances of said town council, are hereby legalized Legalized.

and made valid as though the specific requirements of the law had been complied with.

Publication.

SEC. 2. This act being deemed of immediate importance shall take effect and be in force from and after its publication in *The Iowa State Register*, a newspaper published at Des Moines, Iowa, and the *Indianola Herald* a newspaper published at Indianola, Warren County, Iowa, said publication to be without expense to the State.

CHAPTER 160.

LEGALIZING INCORPORATION AND ORDINANCES OF THE TOWN OF DEEP RIVER.

H. F. 602.

AN ACT to Legalize the Incorporation of the Town of Deep River, Poweshiek County, Iowa, the Election of its Officers and all Acts done and Ordinances Passed by the Council of said Town.

Doubts as to legality.

WHEREAS, Doubts have arisen as to the legality of the incorporation of the town of Deep River, Poweshiek County Iowa, the election of its officers and the ordinances passed by the council of said town; therefore

Be it enacted by the General Assembly of the State of Iowa:

Acts legalized.

SECTION 1. That the incorporation of the said town of Deep River, Poweshiek County, Iowa, the election of its officers, and all the official acts done, and the ordinances passed, by the council of said town, not in contravention with the laws of the State, are hereby legalized, and the same are hereby declared to be valid and binding, the same as though the law had in all respects been strictly complied with in the incorporation of said town the election of its officers and the passing of its ordinances.

Publication.

SEC. 2. This act being deemed of immediate importance shall take effect and be in force from and after its publication in the *Iowa State Register*, published at Des Moines, Polk County, Iowa and the *Montezuma Weekly Republican* published at Montezuma, Poweshiek County, Iowa, without expense to the State.
