CHAPTER 150.

AN ACT to provide for the payment of the claim of Scott county against the state of Iowa for expenses incurred in the care, restraint, and transportation of insane persons not having a known residence in lowa.

Whereas, The laws of the 21st General Assembly of the state of Iowa taking effect July 4, A. D. 1886, provides for the reimbursement of counties for the expenses incurred in sending insane patients to the hospitals for the insane in said state, having no legal settlement in this state or whose legal settlement cannot be ascertained; and

CHAPTER 151.

AN ACT to appropriate money to pay the claims of individuals and S. F. 396. counties in Iowa, for making the exhibit at the World's exposition in New Orleans.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That the sum of \$12,000 dollars be appropriated, or so much thereof as may be necessary, out of any money in the State Treasury not otherwise appropriated, to be paid in the manner hereinafter provided, to such individuals and counties in Iowa that contributed money and have claims for making the exhibit of Iowa at For exhibit at the World's Exposition in New Orleans in 1884–5.

SECTION 2. That the disbursement of said above Executive named sum, or so much thereof as may be needed, shall council to be made by the executive Council of State. who shall same. examine into the report made to the Governor of Iowa by the Commissioner and Treasurer of the Iowa Commission at said exposition and into each item thereof, and if said report is found correct, said Council shall determine
