CHAPTER 187.

H. F. 70.

AN ACT making appropriations for the Institution for Feeble-Minded Children at Glenwood, Iowa.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. **Amounts appropriated.** That there is hereby appropriated out of any moneys in the state treasury, not otherwise appropriated, for the institution for feeble-minded children at Glenwood, Iowa, the following sums, or so much thereof as may be necessary, for the following purposes:

For repairing boiler house and constructing coal sheds.....	\$ 1,000
For contingent and repair fund.....	3,500
For fire escapes to east and west extensions of custodial building...	400
For school supplies.....	300
For bedding supplies.....	300
For further improvement to the water supply system, including deep well pump, pump house, electric motor power for pumping, pipes and fittings.....	3,000

SEC. 2. **In effect.** This act, being deemed of immediate importance, shall take effect and be in force from and after its publication in the Iowa State Register and the Des Moines Leader, newspapers published in Des Moines, Iowa.

CHAPTER 188.

S. F. 281.

AN ACT making appropriation for the payment of the indebtedness of the School for the Deaf.

WHEREAS, The school for the deaf is now in debt on account of its support in a sum approximating five thousand (\$5,000) dollars, therefore,

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. **Amount appropriated.** That there be, and is hereby appropriated, out of any money in the state treasury not otherwise appropriated, the sum of five thousand (\$5,000) dollars, to be used in the payment of the indebtedness of the school for the deaf.

SEC. 2. **How drawn.** That the money herein appropriated shall be drawn from the state treasury on the order of the board of trustees of the Iowa school for the deaf, and shall be used by said board in the payment of the indebtedness now existing against said school on account of its support.
