CHAPTER 10

MOTOR VEHICLES

S. F. 216

AN ACT to amend section four thousand nine hundred eight (4908) and to repeal sections four thousand nine hundred thirteen (4913), four thousand nine hundred fourteen (4914) and four thousand nine hundred seventy-three (4973) of the code, 1924, and enact substitutes therefor, relating to motor vehicle license fees.

Be it enacted by the General Assembly of the State of Iowa:

1 **SECTION 1. Computing fee.** That the law as it appears in section
2 four thousand nine hundred eight (4908) of the code, be and the same
3 is hereby amended by striking out the words "executive council" where
4 they appear in line five (5) and in lines seven (7) and eight (8) and
5 substituting in lieu thereof in each instance the word "department";
6 and by adding to said section the following:

7 "When the license fee, computed according to this section, totals a
8 fraction over a certain number of dollars the fraction of a dollar shall
9 not be computed in arriving at the fee."

1 **SEC. 2. Fee for trucks with pneumatic tires.** That the law as it
2 appears in section four thousand nine hundred thirteen (4913) of the
3 code, 1924, be and the same is hereby repealed and the following en-
4 acted in lieu thereof:

5 "For motor trucks equipped with all pneumatic tires, the annual
6 license fee shall be:

2 in section four thousand nine hundred fourteen (4914) of the code,
3 1924, be and the same is hereby repealed and the following enacted
4 in lieu thereof:

5	"For motor trucks equipped with two or more solid rubber tires.					
6	the annual license fee shall be:					
7	For 1	ton or less	capacity,	\$ 25.00	per annum

1 SEC. 4. Value and weight. That the law as it appears in section
2 four thousand nine hundred seventy-three (4973) of the code, 1924,
3 be and the same is hereby repealed and the following enacted in lieu
4 thereof:

5 "The department shall, on or before the first day of August, 1925,
6 and at such other times as new makes or models of motor vehicles are
7 offered for sale or sold in this state, fix the value and weight of each
8 of the different makes and models of motor vehicles which are sold
9 or offered for sale within the state."

1 SEC. 5. This act shall become effective December 1, 1925.

CHAPTER 11

MOTOR VEHICLES

H. F. 366

AN ACT to amend sections forty-nine hundred ninety-two (4992) and forty-nine hundred ninety-seven (4997) of the code, 1924, relating to motor vehicles.

Be it enacted by the General Assembly of the State of Iowa:

1 SECTION 1. That the law as it appears in section forty-nine hun-
2 dred ninety-two (4992) of the code, 1924, be and the same is hereby
3 amended by inserting a period (.) after the word "highways" in
4 line eight (8) of subsection one (1) and striking all the remainder
5 of said subsection.

1 SEC. 2. That the law as it appears in section forty-nine hundred
2 ninety-seven (4997) of the code, 1924, be and the same is hereby
3 amended by striking out of the last line of said section the words
4 "during the hours of darkness".
