

CHAPTER 209

PROPOSED INTERSTATE BRIDGES

H. F. 262

AN ACT directing the governor of Iowa to appoint a commission to determine and report the feasibility of two (2) interstate bridges between the state of Iowa and the state of Nebraska, and a like commission to determine and report the feasibility of an interstate bridge between the state of Iowa and the state of Wisconsin, and prescribing the duties of each of said commissions.

Be it enacted by the General Assembly of the State of Iowa:

1 **SECTION 1. Commission created—duties.** The governor of Iowa is
2 directed to appoint three (3) commissioners from this state to act
3 with a similar commission appointed by the governor of Nebraska,
4 to ascertain and report the facts relative to the feasibility of construct-
5 ing an interstate bridge across the Missouri river joining the state of
6 Iowa through Woodbury county with the state of Nebraska through
7 Dakota county; also, to report the facts relative to the feasibility of
8 constructing a like bridge across said river and joining the state of
9 Iowa through Pottawattamie county with the state of Nebraska
10 through Douglas county.

1 **SEC. 2. Appointment.** The governor of Iowa is directed to appoint
2 three (3) commissioners from this state to act with a similar commis-
3 sion appointed by the governor of Wisconsin to ascertain and report
4 the facts relative to the feasibility of constructing an interstate bridge
5 across the Mississippi river joining the state of Iowa through Clayton
6 county with the state of Wisconsin through Crawford county.

1 **SEC. 3. Report.** Each of said joint commissions shall report their
2 findings to the governors of their respective states at the earliest
3 possible time, and said reports shall be included by the governor of
4 this state in his message to the general assembly at its regular session
5 in 1927.

CHAPTER 210

INTERSTATE BRIDGES

H. F. 406

AN ACT to amend house file No. 262 enacted by the forty-first general assembly relating to the appointment of a commission to determine and report the feasibility of interstate bridges between the state of Iowa and the state of Nebraska and the state of Iowa and the state of Wisconsin.

Be it enacted by the General Assembly of the State of Iowa:

1 **SECTION 1.** That house file No. 262 enacted by the forty-first general
2 assembly as shown by the enrolled bill on file in the office of the secre-

3 tary of state be and the same is hereby amended by striking out section
4 two (2) of said bill and inserting in lieu thereof the following:

5 "Sec. 2. The governor of Iowa is directed to appoint three (3) com-
6 missioners from this state to act with a similar commission appointed
7 by the governor of Wisconsin to ascertain and report the facts relative
8 to the feasibility of constructing interstate bridges across the Missis-
9 sippi river joining the state of Iowa with the state of Wisconsin."

CHAPTER 211

GRAVES OF SOLDIERS AND SAILORS

S. F. 277

AN ACT to create a commission to locate the unmarked graves of soldiers and sailors who served in the war of the American Revolution, and who are buried in this state; to define the powers of said commission; to authorize the erection of a monument or marker over such graves; and to make an appropriation therefor.

Be it enacted by the General Assembly of the State of Iowa:

1 SECTION 1. **Commission created.** A commission of three (3) per-
2 sons is hereby created for the purpose of determining the location in
3 this state of the unmarked graves of soldiers or sailors who served
4 in the war of the American Revolution, and to supervise, as herein
5 provided, the erection over each of said unmarked graves of a suitable
6 marker or monument.

1 SEC. 2. **Personnel.** Said commission shall be known as the Revolu-
2 tionary war memorial commission. It shall consist of the curator of
3 the historical, memorial, and art department of the state library,
4 who shall be chairman of said commission, and of two (2) other per-
5 sons, one of whom shall be a member of the association known as the
6 Sons of the American Revolution, and one who shall be a member of
7 the association known as the Daughters of the American Revolution,
8 which two (2) latter members shall be appointed by the governor.

1 SEC. 3. **Without compensation.** Said commission shall serve
2 without compensation, but shall be furnished by the executive council
3 with such necessary stationery and postage as will enable it to per-
4 form its duties.

1 SEC. 4. **To locate unmarked graves.** Said commission shall proceed
2 with due diligence to collect and preserve in some proper manner,
3 trustworthy evidence of the location of the unmarked grave of each
4 soldier or sailor of the American Revolution who is buried in this state.

1 SEC. 5. **Approval.** When evidence has been obtained which satisfies
2 the commission or a majority thereof of the location of an unmarked
3 grave in which a soldier or sailor of the American Revolution was
