

CHAPTER 221

PRESIDENTIAL ELECTORS—MILEAGE

H. F. 27

AN ACT making an appropriation to pay the compensation and mileage of the presidential electors for the year 1925.

Be it enacted by the General Assembly of the State of Iowa:

1 SECTION 1. That there is hereby appropriated out of any money in
2 the state treasury not otherwise appropriated, the sum of two hundred
3 sixteen dollars and forty cents (\$216.40) to pay the mileage and the
4 compensation of the presidential electors for their services rendered
5 in January 1925, as provided for in section nine hundred seventy-one
6 (971) of the code, 1924.

1 SEC. 2. This act being deemed of immediate importance shall take
2 effect and be in force from and after its publication in the Eldora
3 Herald, a newspaper published in Eldora, Iowa, and the Des Moines
4 Capital, a newspaper published in Des Moines, Iowa.

CHAPTER 222

INAUGURAL EXPENSE

S. F. 32

AN ACT making appropriation to defray the expense of the inaugural ceremonies.

Be it enacted by the General Assembly of the State of Iowa:

1 SECTION 1. There is hereby appropriated out of the funds in the
2 state treasury, not otherwise appropriated, the sum of four hundred
3 thirteen dollars, or so much thereof as may be necessary, to pay the
4 expenses incurred on account of the inaugural ceremonies and recep-
5 tion. Warrants shall be drawn upon the treasurer for the sum herein
6 appropriated in favor of the adjutant general upon the filing of vouch-
7 ers therefor with the auditor of state.

1 SEC. 2. This act being deemed of immediate importance shall take
2 effect and be in force from and after its passage and publication in

3 the Des Moines Capital, and Des Moines Register, newspapers pub-
4 lished in Des Moines, Iowa.

CHAPTER 223

SUNDRY STATE EXPENSES

H. F. 50

AN ACT making an appropriation for the payment of typewriter rental, fees of legislative chaplains and other expenses of the general assembly and the payment of mileage and additional compensation for certain officers of the special session of the fortieth general assembly, and the payment of expenses of certain mine inspectors.

Be it enacted by the General Assembly of the State of Iowa:

1 SECTION 1. **Miscellaneous items.** That there is hereby appropriated
2 out of any funds in the state treasury, not otherwise appropriated,
3 the sum of three thousand dollars (\$3000.00) or so much thereof as
4 shall be necessary for the following purposes:
5 To the several typewriter agencies for rental of machines for the
6 general assembly a sum equal to ten dollars (\$10.00) for each machine
7 for the three months' period.
8 To the several ministers of the state for their services as chaplains
9 of the senate and house of representatives of the forty-first general
10 assembly the sum of one thousand dollars (\$1000.00) or so much
11 thereof as shall be necessary to pay the same on the basis of the
12 usual fee of five dollars (\$5.00).
13 To the Des Moines Rubber Stamp Works for badges for the general
14 assembly the sum of one hundred dollars (\$100.00).
15 To certain officers of the special session of the fortieth general
16 assembly for mileage in accordance with house joint resolution No. 11
17 of the said special session of the fortieth general assembly the sum
18 of forty-one and eighty hundredths dollars (\$41.80) as follows:
19 Frank Vetter.....\$11.00
20 Oley Nelson 2.60
21 Chas. P. Denison..... 16.20
22 T. D. Doke..... 12.00
23 To R. H. Rhys to reimburse him for expenses incurred in the per-
24 formance of his duty as mine inspector, the sum of fifty-eight and
25 forty-eight hundredths dollars (\$58.48).
26 To Chas. A. Lindenau for services rendered at the extra session
27 of the fortieth general assembly, one hundred forty-four dollars
28 (\$144.00).
