CITIES AND TOWNS—PURCHASE OF LANDS AND BUILDINGS FOR HOSPITAL PURPOSES

H. F. 56

AN ACT to amend sections sixty-one hundred ninety-five (6195), sixty-two hundred eleven (6211), and sixty-two hundred thirty-nine (6239), code, 1935, relating to the power of cities and towns to purchase land and buildings for hospital purposes; to levy annual taxes for purchasing, constructing or reconstructing buildings to be used for hospitals or purchasing sites therefor and for the retirement of bonds issued in payment thereof; and to incur indebtedness for said purposes.

Be It Enacted by the General Assembly of the State of Iowa:

- SECTION 1. Section sixty-one hundred ninety-five (6195), code, 1935, is hereby amended by changing the period to a comma at the end of sub-section number one (1) and adding "including buildings thereon to be used for hospitals."
- SEC. 2. Section sixty-two hundred eleven (6211), code, 1935, is hereby amended by striking from paragraph twenty-six (26) following the word "of" in line seven (7) "constructing hospitals or purchas-
- 4 ing sites therefor and for the retirement of bonds issued in payment 5 thereof" and inserting in lieu thereof "purchasing sites for hospitals
