

3 June 30, 1943, emergency funds for the Department of Health, of the
4 State of Iowa, for the purpose of salaries, support, maintenance and
5 miscellaneous purposes of the Division of Vital Statistics, under the
6 Department of Health, the sum of eleven thousand dollars.

1 SEC. 2. This act being deemed of immediate importance shall be
2 in full force and effect on its publication in the Argo Gazette, a news-
3 paper published at West Union, Iowa, and in the Mason City Globe
4 Gazette, a newspaper published at Mason City, Iowa.

CHAPTER 15

APPROPRIATION FOR SEWER PROJECT ADJACENT TO IOWA SOLDIERS' ORPHANS HOME IN DAVENPORT

H. F. 131

AN ACT to appropriate not to exceed the sum of twenty-six hundred fifty dollars for the purpose of paying one half of the cost of the construction and installation of a sewer, septic tank and disposal field in the city of Davenport, Iowa, in a public street named Eastern Avenue adjoining real estate owned by the state of Iowa and used for the Iowa Soldiers' Orphans Home.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1 There is hereby appropriated from the State Treasury,
2 out of any funds not otherwise appropriated, the sum of twenty-six
3 hundred fifty dollars or so much thereof as may be necessary for the
4 purpose of paying one half of the cost of constructing and installing
5 a sewer in and a septic tank and disposal field adjacent to the street
6 of Eastern Avenue in the City of Davenport, Iowa, which street adjoins
7 property owned by the State of Iowa used for the purpose of the Iowa
8 Soldiers' Orphans Home which sewer is to be in Eastern Avenue in
9 the City of Davenport, Iowa, commencing approximately at the south
10 line of Kimberly Road where the same joins Eastern Avenue and ex-
11 tending southerly on Eastern Avenue to approximately Duck Creek
12 all in the City of Davenport, Scott County, Iowa.

1 SEC. 2. The Iowa State Board of Control is authorized to expend
2 the money herein appropriated for such purpose and to pay said sum
3 to the city of Davenport, Iowa, on the completion of said sewer, septic
4 tank and disposal field at the southerly terminus thereof, said sewer,
5 septic tank and disposal field to be constructed in accordance with
6 plans and specifications to be approved prior to construction by the
7 Iowa State Board of Control.
