- within this state, while under the influence of intoxicating liquor, narcotics, or other habit-forming drug, or to operate an aircraft in the air space above this state or on the ground or water within this state in a careless or reckless manner so as to endanger the life or property of another.
- SEC. 2. Any person who violates the provisions of this act shall be guilty of a misdemeanor and upon conviction thereof shall be punished accordingly.

CHAPTER 182

AIRPORT ZONING

H. F. 374

AN ACT to amend sections three hundred twenty-nine point one (329.1), three hundred twenty-nine point four (329.4), three hundred twenty-nine point six (329.6), three hundred twenty-nine point nine (329.9) and three hundred twenty-nine point twelve (329.12), code 1946, relating to airport zoning, actions for the establishment of airport zoning regulations with respect to extra-territorial airport hazard areas, the courts wherein such actions may be maintained and the parties to such actions, airport zoning commissions, action by counties with respect to airport zoning and airport zoning boards of adjustment.

Be It Enacted by the General Assembly of the State of Iowa:

- SECTION 1. Subsection two (2) of section three hundred twentynine point four (329.4), Code 1946, is hereby amended by inserting after the word "area" and before the word "is" in line fourteen (14) thereof, the words "or any part thereof".
- 1 SEC. 2. Section three hundred twenty-nine point six (329.6), 2 Code 1946, is hereby amended by striking from line ten (10) thereof the word "municipality" and inserting in lieu thereof, the words "airport hazard area, or any part thereof," and said section is hereby 3 further amended by striking the word "proceedings" in lines thirteen (13) and fourteen (14) thereof and inserting in lieu thereof the word "provisions" and said section is hereby further amended by 5 6 striking the period (.) at the end of line fifteen (15) thereof, and inserting in lieu thereof, the following: "provided, however, that 8 9 10 such municipality shall be joined as a party defendant in any such 11 action."
 - SEC. 3. Section three hundred twenty-nine point nine (329.9), Code 1946, is hereby amended by adding thereto following the first sentence thereof, the following: "Any action taken on the part of any county under this chapter shall be by resolution of the board of supervisors thereof and no such action shall be taken without a majority of the board of supervisors voting therefor and consenting thereto." and said section is hereby further amended by striking therefrom the last sentence thereof, and by inserting in lieu thereof, the following: "The airport zoning commission shall consist of two members from each municipality selected by the governing body thereof and one additional member to act as chairman and to be selected

by a majority vote of the members selected by the municipality. The 12 terms of the members of the airport zoning commission shall be 13 for six years excepting that when the board shall first be created, one 14 15 of the members appointed by each municipality shall be appointed for 16 a term of two years and one for a term of four years. Members may 17 be removed for cause by the appointing authority upon written charges after public hearing. Vacancies shall be filled for the unexpired 18 19 term of any member whose office becomes vacant in the same manner 20 in which said member was selected."

- Section three hundred twenty-nine point twelve (329.12), Code 1946, is hereby amended by inserting therein following the first paragraph thereof, the following: "The concurring vote of a 3 4 majority of the board shall be necessary to reverse any order, requirement, decision or determination of any administrative official or to 6 decide in favor of the applicant on any matter upon which it is required to pass under any regulations adopted pursuant to this chapter or to effect any variance therefrom." and said section is 8 hereby further amended by striking from the last line thereof, the 9 word "term" and inserting in lieu thereof the word "office" and said 10 11 section is hereby further amended by striking the period (.) at the end thereof and inserting in lieu thereof the following: "in the same 12 manner in which said member was selected. The terms of the members 13 14 of the board of adjustment shall be for five years, excepting that when 15 the board shall first be created, one of the members appointed by each municipality shall be appointed for a term of two years and one for a term of four years." 16 17
 - SEC. 5. This act shall not affect the validity of any action taken by any political subdivision creating an airport zoning commission, appointing any existing comprehensive zoning commission as an airport zoning commission or for any other purpose under the provisions of chapter three hundred twenty-nine (329), Code 1946, prior to the effective date of this act.
- 1 SEC. 6. Subsection four (4) of section three hundred twenty-nine point one (329.1), Code 1946, is hereby amended by inserting follow-2 ing the comma (,) after the word "village" and before the word "town" in line two (2) thereof the word "or". Said subsection is further 3 4 5 hereby amended by striking from line two (2) thereof the following "or township," and said subsection is further hereby amended by striking all of said subsection following the word "state" in line 6 ٠7 two (2) thereof and inserting in lieu thereof a period (.). 8
- SEC. 7. This act being deemed of immediate importance shall be 1 in full force and effect from and after its passage and publication in the Toledo Chronicle, a newspaper published at Toledo, Iowa, and 3 in the Lake Mills Graphic, a newspaper published at Lake Mills, Iowa.
