## CHAPTER 167

## **POWERS OF MUNICIPAL CORPORATIONS**

## H. F, 463

An Act to amend chapters one hundred forty-five (145), one hundred forty-six (146) and one hundred sixty-four (164), Acts of the Fifty-fourth General Assembly, relating to the council-manager form of municipal government by popular election, and relating to general powers of cities and towns governments, and to mayorcouncil form of city government.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. Chapter one hundred sixty-four (164), Acts of the Fifty-fourth General Assembly, is amended by adding at the end of section one (1) the following: "If, at any meeting, the mayor is not 2 3 4 present, the members of the council may select one of their number to act as presiding officer pro tem whose acts as such presiding officer pro tem shall have the same force and legality as though per-5 6 7 formed by the regularly elected mayor, and such presiding officer pro 8 tem shall have power to sign all resolutions or ordinances and to exe-9 cute all contracts or other documents adopted or approved at such 10 meeting. The presiding officer of the council, whether the regularly elected presiding officer or a presiding officer pro tem, shall have the 11 12 right to cast a vote as a member of the council.".

1 SEC. 2. Chapter one hundred sixty-four (164), Acts of the Fifty-2 fourth General Assembly, is amended by adding at the end of section 3 seven (7) the following new subsection:

4 "20. He shall appoint a treasurer subject to the approval of the 5 council.".

1 SEC. 3. Chapter one hundred sixty-four (164), Acts of the Fifty-2 fourth General Assembly, is amended by inserting after the word 3 "power" in line twenty-four (24) of section seven (7) the words "to 4 suspend or".

5 Further amend said section by striking from lines twenty-seven 6 (27) and twenty-eight (28) the words ", except that any administra-7 tive assistants to the manager shall hold office at his pleasure".

8 Further amend said section by inserting before the period in line 9 eleven (11) the words "and such administrative assistants to the man-10 ager shall hold office at his pleasure".

1 SEC. 4. Section one (1), chapter one hundred forty-six (146), laws 2 of the fifty-fourth (54th) general assembly, be and is hereby amended 3 by striking from line two (2) thereof the words "city manager by 4 ordinance".

1 SEC. 5. Section one (1), chapter one hundred forty-five (145), laws 2 of the fifty-fourth (54th) general assembly be and is hereby amended 3 by striking from line five (5) thereof the words "council manager 4 form by ordinance".
