CHAPTER 261

SALE OF STATE LANDS

S. F. 808

AN ACT authorizing and empowering the executive council to sell certain lands belonging to the state of Iowa situated in the southeast quarter of section twenty-four, Township seventy-eight north, Range three east of the Fifth principal meridian, Scott county, Iowa.

WHEREAS, the state of Iowa is the owner of the following described real estate, to-wit:

That part of the northeast quarter of the southeast quarter of section twenty-four, township seventy-eight north, range three east of the fifth principal meridian, more particularly described as follows: Commencing at a point in the north line of East Denison Avenue in the city of Davenport, Iowa, which point is four hundred fifty-eight feet east of the east line of Bridge Avenue; thence north six hundred forty-one and fifty-two hundredths feet to a point on the center line of a twenty foot alley which point is four hundred fifty-eight feet east of the east line of Bridge Avenue; thence east twenty feet; thence south six hundred forty-one and fifty-two hundredths feet to a point in the north line of East Denison Avenue; thence west twenty feet to the point of beginning, which land was used in connection with The Iowa Annie Wittenmyer Home at Davenport, Iowa, and

WHEREAS, the said land is no longer desired for use in that connection, now, therefore

Be It Enacted by the General Assembly of the State of Iowa:

- SECTION 1. The executive council be and hereby is authorized and empowered to sell to the city of Davenport, Iowa, the following de-

- of a twenty foot alley which point is four hundred fifty-eight feet
- 12 east of the east line of Bridge Avenue; thence east twenty feet; thence
- south six hundred forty-one and fifty-two hundredths feet to a point in the north line of East Denison Avenue; thence west twenty feet
- 15 to the point of beginning, which land was used in connection with
- The Iowa Annie Wittenmyer Home at Davenport, Iowa, at such price and upon such terms as the executive council shall deem most advan-
- 18 tageous to the state of Iowa.
- 1 Sec. 2. The funds accruing from such sale shall be deposited with 2 the treasurer of state to the credit of the general fund.
- SEC. 3. The governor and secretary of state are hereby authorized to execute all necessary deeds of conveyance required to convey said premises to the city of Davenport, Iowa.
