SCHOOL TRANSPORTATION

"It is provided, however, that in areas of any county having a population of over one hundred and fifty thousand (150,000), where, in the opinion of the board, the volume of traffic is such that the pupils' safety depends upon transportation, regular transportation may be provided for pupils living less than the statutory walking distance from the designated school.".

- (297.15), Code 1954, is amended by striking from lines two (2) and three (3) the words ", situated wholly outside of a city or town," and by inserting after the word "estate" in line two (2) the words ", situated wholly outside of a city or town,".
