1 Section 1. Section three hundred thirty-three point three (333.3), 2 Code 1954, is amended by striking from line two (2) of subsection 3 three (3) the words, "of trial jury" and inserting in lieu thereof the 4 words, "in jury trials".

COMPENSATION OF COUNTY OFFICERS

AN ACT to amend chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, relating to the compensation of county officers.
Be It Enacted by the General Assembly of the State of Iowa:

Section 1. Section one (1) of chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, is hereby amended by striking therefrom subsections one (1) to thirteen (13), inclusive, and inserting in lieu thereof the following:
"1. Less than ten thousand $(10,000)$, four thousand $(4,000)$ dollars.
2. Ten thousand $(10,000)$ and less than fifteen thousand $(15,000)$, four thousand one hundred fifty $(4,150)$ dollars.
3. Fifteen thousand $(15,000)$ and less than twenty thousand ( $20,-$ $000)$, four thousand three hundred $(4,300)$ dollars.
4. Twenty thousand $(20,000)$ and less than twenty-five thousand
$(25,000)$, four thousand four hundred fifty $(4,450)$ dollars.
5. Twenty-five thousand $(25,000)$ and less than thirty thousand $(30,000)$, four thousand six hundred $(4,600)$ dollars.
6. Thirty thousand $(30,000)$ and less than thirty-five thousand $(35,000)$, four thousand seven hundred fifty $(4,750)$ dollars.
7. Thirty-five thousand $(35,000)$ and less than forty thousand $(40,000)$, four thousand nine hundred $(4,900)$ dollars.
8. Forty thousand ( 40,000 ) and less than forty-five thousand (45,000 ), five thousand fifty $(5,050)$ dollars.
9. Forty-five thousand ( 45,000 ) and less than fifty thousand ( $50,-$ 000 ), five thousand two hundred $(5,200)$ dollars.
10. Fifty thousand $(50,000)$ and less than sixty thousand $(60,000)$, five thousand five hundred $(5,500)$ dollars.
11. Sixty thousand $(60,000)$ and less than seventy thousand ( $70,-$ 000 ), five thousand eight hundred $(5,800)$ dollars.
12. Seventy thousand $(70,000)$ and less than eighty thousand ( $80,-$ 000 ), six thousand one hundred $(6,100)$ dollars.
13. Eighty thousand $(80,000)$ and over, six thousand four hundred $(6,400)$ dollars."

SEC. 2. Section two (2) of chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, is hereby amended by striking therefrom subsections one (1) to fourteen (14), inclusive, and inserting in lieu thereof the following:
" 1 . Less than ten thousand $(10,000)$, four thousand $(4,000)$ dollars.
2. Ten thousand $(10,000)$ and less than fifteen thousand $(15,000)$, four thousand one hundred fifty $(4,150)$ dollars.
3. Fifteen thousand $(15,000)$ and less than twenty thousand (20,000 ), four thousand three hundred $(4,300)$ dollars.
4. Twenty thousand $(20,000)$ and less than twenty-five thousand $(25,000)$, four thousand four hundred fifty $(4,450)$ dollars.
5. Twenty-five thousand $(25,000)$ and less than thirty thousand $(30,000)$, four thousand six hundred $(4,600)$ dollars.
6. Thirty thousand $(30,000)$ and less than thirty-five thousand $(35,000)$, four thousand seven hundred fifty $(4,750)$ dollars.
7. Thirty-five thousand $(35,000)$ and less than forty thousand $(40,000)$, four thousand nine hundred $(4,900)$ dollars.
8. Forty thousand ( 40,000 ) and less than forty-five thousand ( $45,-$ 000 ), five thousand fifty ( 5,050 ) dollars.
9. Forty-five thousand $(45,000)$ and less than fifty thousand ( $50,-$ 000 ), five thousand two hundred $(5,200)$ dollars.
10. Fifty thousand $(50,000)$ and less than sixty thousand $(60,000)$, five thousand five hundred $(5,500)$ dollars.
11. Sixty thousand $(60,000)$ and less than seventy thousand (70,000 ), five thousand eight hundred $(5,800)$ dollars.
12. Seventy thousand $(70,000)$ and less than eighty thousand ( $80,-$ $000)$, six thousand one hundred $(6,100)$ dollars.
13. Eighty thousand $(80,000)$ and less than one hundred twentyfive thousand $(125,000)$ six thousand six hundred $(6,600)$ dollars.
14. One hundred twenty-five thousand $(125,000)$ and over, seven thousand six hundred $(7,600)$ dollars."

SEC. 3. Section four (4) of chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, is hereby amended
by striking from line four (4) thereof the word "eleven" and inserting in lieu thereof the words "twelve dollars and fifty cents (\$12.50)"; by striking from lines five (5) and six (6) the words "thirty-six hundred" and inserting in lieu thereof the words "four thousand $(4,000)$ "; by striking from lines seven (7) and eight (8) the words "four thousand" and inserting in lieu thereof the words "four thousand four hundred $(4,400) "$; by striking from line nine (9) the words "five thousand" and inserting in lieu thereof the words "five thousand four hundred $(5,400)$ "; by striking from line eleven (11) the words "fiftyeight hundred" and inserting in lieu thereof the words "six thousand two hundred $(6,200)$ "; by striking from line fourteen (14) the words "fifty-two hundred" and inserting in lieu thereof the words "fifty-six hundred (5,600)".

SEC. 4. Section six (6) of chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, is hereby amended by striking therefrom subsections one (1) to fifteen (15), inclusive, and inserting in lieu thereof the following:
"1. Less than ten thousand $(10,000)$, three thousand two hundred $(3,200)$ dollars.
2. Ten thousand $(10,000)$ and less than fifteen thousand $(15,000)$, three thousand three hundred fifty $(3,350)$ dollars.
3. Fifteen thousand ( 15,000 ) and less than twenty thousand (20,000 ), three thousand five hundred $(3,500)$ dollars.
4. Twenty thousand $(20,000)$ and less than twenty-five thousand $(25,000)$, three thousand six hundred fifty $(3,650)$ dollars.
5. Twenty-five thousand $(25,000)$ and less than thirty thousand $(30,000)$, three thousand eight hundred $(3,800)$ dollars.
6. Thirty thousand $(30,000)$ and less than thirty-five thousand ( 35,000 ), three thousand nine hundred fifty (3,950) dollars.
7. Thirty-five thousand $(35,000)$ and less than forty thousand (40,$000)$, four thousand one hundred $(4,100)$ dollars.
8. Forty thousand (40,000) and less than forty-five thousand (45,000 ), four thousand two hundred fifty $(4,250)$ dollars.
9. Forty-five thousand $(45,000)$ and less than fifty thousand (50,000 ), four thousand four hundred $(4,400)$ dollars.
10. Fifty thousand $(50,000)$ and less than sixty thousand $(60,000)$, four thousand seven hundred $(4,700)$ dollars.
11. Sixty thousand ( 60,000 ) and less than seventy thousand (70,000 ), five thousand eight hundred $(5,800)$ dollars.
12. Seventy thousand (70,000) and less than eighty thousand (80,000 ), six thousand one hundred $(6,100)$ dollars.
13. Eighty thousand $(80,000)$ and less than one hundred thousand $(100,000)$, six thousand six hundred $(6,600)$ dollars.
14. One hundred thousand $(100,000)$ and less than one hundred fifty thousand $(150,000)$, seven thousand two hundred $(7,200)$ dollars.
15. One hundred fifty thousand $(150,000)$ and over, seven thousand six hundred $(7,600)$ dollars."

SEC. 5. Section two hundred thirty-one point eight (231.8), Code 1954, as amended by the Acts of the Fifty-sixth General Assembly is further amended as follows:

Subsection one (1), line five (5), strike "eight dollars per day or one dollar per hour" and insert "twelve dollars per day or one dollar
and a half per hour".
Subsection one (1), line seven (7), strike "twenty-nine hundred" and insert "thirty-four hundred".

Subsection two (2), line eight (8), strike "forty-four hundred" and insert "forty-nine hundred".

Subsection two (2), line twelve (12), strike "thirty-three hundred twenty" and insert "thirty-eight hundred twenty".

Subsection three (3), line five (5), strike "forty-nine hundred" and insert "fifty-four hundred".

Subsection three (3), line nine (9), strike "thirty-nine hundred twenty" and insert "forty-four hundred twenty".

Subsection four (4), line four (4), strike "fifty-eight hundred" and insert "sixty-three hundred".

Subsection four (4), line eight (8), strike "forty-three hundred twenty" and insert "forty-eight hundred twenty".

Subsection five (5), line six (6), strike "twenty-two hundred" and insert "twenty-seven hundred".

Subsection five (5), lines nine (9) and ten (10), strike "twentyseven hundred" and insert "thirty-two hundred".

Subsection six (6), line fifteen (15), strike "forty-six hundred" and insert "fifty-one hundred".

SEc. 6. Section five (5) of chapter one hundred seventy-three (173), Acts of the Fifty-sixth General Assembly, is amended by adding the following subsections:
"Section three hundred forty point two (340.2), Code 1954, is further amended by striking the period (.) after the word 'principal' in line six (6) and inserting in lieu thereof the following: '; however, in counties with a population of one hundred thousand $(100,000)$ or more, first and second deputies, and any deputy in charge of the motor vehicle registration and title department, shall receive an annual salary of eighty (80) percent of his or her principal.'
"Section three hundred forty point two (340.2), Code 1954, is further amended by striking the period (.) at the end of line eleven (11) and inserting in lieu thereof the following: '; however, in counties with a population of one hundred thousand $(100,000)$ or more, deputies (where more than two (2) deputies are required) and the first assistant to the deputy in charge of the motor vehicle registration and title department, shall receive an annual salary of sixty-five (65) percent of their principal.'"

SEc. 7. This Act shall be in full force and effect on and after January $1,1958$.
