Chairman Sands called the meeting to order at 10:30 AM

The committee stood at ease at 10:31 AM for both parties to caucus.

The committee reconvened at 10:47 AM.

Roll call was read and a quorum was present.

As there were no corrections, amendments and/or deletions to the April 15<sup>th</sup> and April 16<sup>th</sup> meeting minutes, they were unanimously approved.

The following bill was assigned:

[SF 2352](#) – Windschitl- Chair, Landon & Kearns

Chairman asked unanimous consent to go into a Sub Committee of the Whole for Consideration of [SF 2352](#). The Chair recognized Representative Windschitl for opening comments and explanation on [SF 2352](#). An Act relating to the additional homestead credit for certain disabled veterans. Representative Windschitl moved the bill and was passed on short form.

The Sub Committee of the Whole dissolved back into the Committee. The Committee reconvened.

Chairman Sands recognized Representative Windschitl for opening remarks on [SF 2352](#). An Act relating to the additional homestead credit for certain disabled veterans.

The bill was moved and passed by the vote 21 Aye, 0 Nay and 4 Absent. The bill will move to the house floor as a Senate File.

Chairman Sands recognized Representative Stanerson for opening remarks on [SF 2337](#). An Act relating to the child and dependent care credit available against the individual income tax.

The bill was moved and passed by the vote 21 Aye, 0 Nay and 4 Absent. The bill will move to the house floor as a Senate File.

Chairman Sands recognized Representative Forristall for opening remarks on [SF 2340](#) . An Act modifying provisions applicable to the solar energy system tax credit, and including effective date.

The bill was moved and passed by the vote 21 Aye, 0 Nay and 4 Absent. The bill will move to the house floor as a Senate File.

Chairman Sands recognized Representative Landon for opening remarks on [SF 2343](#) . An Act relating to qualification requirements for the renewable energy tax credit.

The bill was moved and passed by the vote 21 Aye, 0 Nay and 4 Absent. The bill will move to the house floor as a Senate File.

Chairman Sands recognized Representative Moore for opening remarks on [SF 2344](#) . An Act relating to renewable fuels, by providing for biobutanol and biobutanol blended gasoline, modifying the rate of the E-15 plus gasoline promotion tax credit and extending provisions for renewable fuel tax credits and a biodiesel 4 production refund, and including effective date.

The bill was moved and passed by the vote 21 Aye, 0 Nay and 4 Absent. The bill will move to the house floor as a Senate File.

As there was no additional business to come before the committee Representative Vander Linden moved to adjourn at 11:04 AM.
