Miller moved [SF 203](#) as amended, a roll call vote was taken, having received 20 ayes, 0 nays, and 1 absent, Rep.

Gustafson, [SF 203](#) passed as amended as a committee bill.

The Chair recognized Rep. Miller for opening remarks on [SF 276](#), a bill for an act relating to the administration of medical licenses by the board of medicine. Following discussion of the bill Rep. Miller moved [SF 276](#), a roll call vote was taken, having received 20 ayes, 0 nays, 1 absent, Rep. Gustafson, [SF 276](#) passed as a committee bill.
