Roll Call was read and a quorum was present.

As there were no corrections, amendments and/or deletions to the previous meeting minutes, they were unanimously approved.

Representative Meyer turned the Chair over to Representative Wood.

Chairwoman Wood recognized Representative Meyer, A. for opening remarks on [HF 102](#): *A Bill for an Act relating to noneconomic damage awards against health care providers, and including effective date and applicability provisions.*

Chairwoman Wood recognized Representative Wilz for amendment 102.77. The amendment was moved and passed on short form.

Chairwoman Wood recognized Representative Lohse for amendment 102.130.

Representative Lohse moved the amendment and requested a division and a record.

The amendment failed with a vote of 9 Ayes (Representatives Wessel-Kroeschell, Andrews, Baeth, Brown-Powers, Forbes, Lohse, Madison, Matson, Turek), 12 Nays (Representatives Meyer, A., Wood, Bergan, Best, Boden, Bradley, Fry, Jeneary, Kniff McCulla, Lundgren, Moore, T., Wilz) and 0 Absent.

Chairwoman Wood recognized Representative Meyer, A. for amendment 102.121.

The amendment was moved and passed on short form.

The bill as amended was moved and passed with a vote of 12 Aye (Representatives Meyer, A., Wood, Bergan, Best, Boden, Bradley, Fry, Jeneary, Kniff McCulla, Lundgren, Moore, T., Wilz), 9 Nay (Representatives Wessel-Kroeschell, Andrews, Baeth, Brown-Powers, Forbes, Lohse, Madison, Matson, Turek) , and 0 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Wood turned the Chair over to Representative Meyer, A.
