Senator Rozenboom called the meeting to order at 11:08 am. Roll call was taken silently. The minutes of the previous meeting were unanimously approved.

Subcommittee assignments were sent electronically and the Governor appointee lists were distributed to each member this week.

Senator Rozenboom called up [HF 2278](#) & recognized Senator Green. Senators Green, Giddens & Westrich all signed the Subcommittee Report. Senator Green gave opening comments and there was no discussion. Senator Green moved the bill & it passed shortform with all in favor. The bill moved to the calendar.

Senator Rozenboom next called up [HF 2393](#) & recognized Senator Green. Senators Green, Trone Garriott, and Garrett all signed the Subcommittee Report. Opening comments were made by Senator Green. There was no discussion. Senator Green moved the bill and it passed shortform with all in favor. It was moved to the calendar.

Senator Rozenboom recognized Senator Zaun for [HF 2545](#), with Senators Zaun & Taylor signing the report and Senator Donahue declining to sign. Opening comments were made by Senator Zaun. There was discussion. Senator Zaun gave closing comments. The bill passed 11-5 with a short form vote, with Senators Quirnbach, Celsi, Donahue, Giddens & Trone Garriott voting no. It was moved to the calendar.

Senator Rozenboom recognized Senator Kraayenbrink for [HF 2553](#). Senators Kraayenbrink & Evans signed the report, with Senator Celsi declining. Opening comments were made and Senator Celsi was recognized for amendment .3704. Discussion and closing comments on the amendment were made. A shortform vote failed. After closing comments on the bill, a short form vote was taken and passed 11-5, with Senators Quirnbach, Celsi, Donahue, Giddens, & Trone Garriott voting no. It was moved to the calendar.

Senator Rozenboom recognized Senator Evans for [HF 2586](#). The Subcommittee Report was signed by Senators Evans & Garrett, with Senator Quirnbach declining. Opening comments were given. There was discussion and then closing comments. The bill passed with a shortform vote of 11-5, with Quirnbach, Celsi, Donahue, Giddens & Trone Garriott voting no. The bill was moved to the calendar.

Senator Rozenboom recognized Senator Green for [HF 2615](#). The report was signed by Senators Green, Garrett & Trone Garriott. Opening comments were given. There was no discussion and then closing comments. The bill passed with a shortform vote with all in favor. It was moved to the calendar.

Senator Rozenboom recognized Senator Taylor for [HF 2617](#). The Sub Report was signed by Senators Taylor & Salmon, with Senator Quirnbach declining. Opening comments were made. There was an amendment (.3667) and Senator Taylor gave opening remarks on it. Discussion followed & then closing comments on the amendment. The amendment passed. There was discussion on the bill followed by closing comments. The bill, as amended, passed with a shortform vote of 11-5, with

Quirmbach, Celsi, Donahue, Giddens, and Trone Garriott voting no. The bill was moved to the calendar.

Senator Rozenboom turned the chair over to Senator Taylor and was recognized as chair of [HF 2465](#). The Sub Report was signed by Senators Rozenboom, Giddens & Kraayenbrink. Opening comments were made. There was no discussion. Shortform vote passed with all voting for it. Moved to the calendar.

The chair was turned back to Senator Rozenboom. He next recognized Senator Cournoyer for [HF 2487](#). Senators Cournoyer & Evans signed the report, with Senator Donahue declining. Opening comments were given & there was discussion. Closing remarks were made and the bill passed shortform with all voting for it. It was moved to calendar.

Senator Rozenboom reminded everyone to get their Governor appointments done and to turn in their yellow jackets.

Senator Westrich moved to adjourn at 12:50 pm
