Schulte for HSB 83, an act relating to county and state responsibilities for mental health, mental retardation, and developmental disabilities services for adults and children and including effective date provisions, for opening remarks. There is an amendment. The Chair recognized Rep. Smith for remarks on amendment HSB83.984. Rep. Smith moved the amendment HSB83.984 by short form, the amendment passed. The chair recognized Rep. Schulte for closing remarks on HSB 83 as amended. Rep. Schulte moved the bill HSB 83 as amended.

Roll was called; there were 21 Ayes and 0 Nays. Having received the constitutional majority the bill now goes to the floor as a Committee bill.

The chair recognized Rep. Schulte for HF 203, an act relating to indemnification of hospitals participating in the volunteer health care provider program, for opening remarks. There is an amendment. Schulte for closing remarks on HF 203 as amended. Rep. Schulte moved the bill.
