Representative Raecker called the Appropriations Committee meeting to order at 12:40 PM. Roll was called; quorum present. Minutes from the April 11, 2012 meeting were approved. Republicans and Democrats went to caucus at 12:41 PM. Representative Raecker reconvened the committee meeting at 1:56 PM. Representative Raecker requested and received unanimous consent to dissolve the committee into a subcommittee of the whole for consideration of HF 2475. Representative Raecker recognized Representative Hagenow for opening remarks on HF 2475, a bill for an act relating to taxation and local government budgets by providing for an increase in the amount of the earned income tax credit, establishing and modifying property assessment limitations, providing for certain property tax replacement payments, modifying the assessment and taxation of telecommunications company property, establishing budget limitations for counties and cities, modifying certain reporting requirements, establishing a property tax credit for certain commercial, industrial, and railway property, establishing a multiresidential property classification, providing penalties, making appropriations, and including effective date, retroactive applicability, and other applicability provisions. Discussion followed. Representative Hagenow was recognized for closing comments and moved the bill, which passed, short form. HF 2475 will move to the full committee for consideration. Representative Raecker requested and received unanimous consent to dissolve the subcommittee of the whole and return to the full committee. With no further opening remarks from Representative Hagenow, The Chair recognized Representative Olson for remarks on HF 2475. Representative Hagenow was then recognized for closing

comments, and moved the bill, which passed 16-8.
