IOWA 911 COMMUNICATIONS COUNCIL MEETING — DECEMBER 2023

Meeting. The 911 Communications Council met on December 14, 2023, at the Dallas County Human Services Campus in Adel. A recording of the meeting is available here.

911 Program Financial Report and Program Update. Blake DeRouchey, 911 Program Manager and State Administrator at the Department of Homeland Security and Emergency Management (HSEMD), provided the Council with the following updates on the 911 Program and its current financial standing:

- US Cellular Samsung S20 Series issue discussion.
- The required 911 annual report for the legislature has been submitted. The report can be found here.
- A reminder will be sent out for the required Public Safety Answering Point (PSAP) forms which will be due in the second half of the month of December.
- Geographic Information System (GIS) Grants. In FY 2024 Q1, counties received a total of \$321,000 in GIS grant funding. Funding is contingent on verification that the applicant possesses 98.0% match rates with GIS and 98.0% match rates with the Automatic Location Identification (ALI) system. In November 2023, all counties met the benchmarks. Data is updated/uploaded monthly.
- Training Fund Requests. No training fund requests were received for this month.

Shared Services Update. The HSEMD awarded Zetron NG911 contracts in December 2017 and July 2022 for shared 911 call-handling equipment. Zetron also provides a call-taking system that offers computer-aided design (CAD), 911 mapping, and emergency medical dispatch software in implementing NG911 protocols and systems. Decatur County will become an active shared services location in 2024.
