# **Iowa Lottery Report On Operations**

## <u>Introduction</u>

The Iowa Lottery continues to build upon the strong results of its previous two years, with Fiscal Year 2023 on track to break records for lottery sales, proceeds to state causes, prizes to players, and sales commissions to local businesses across the state. The time period of FY 2021-2023 is expected to be the most successful three years in Iowa Lottery history.

They are the only years in which total annual lowa Lottery sales have exceeded \$430 million, and each year the lottery surpassed \$97 million in proceeds for the State of Iowa. The Iowa Lottery is in strong position, and extends sincere thanks to its staff, retailers, customers and policymakers for their continued support of Lottery entertainment in Iowa.

Specific to FY 2023, gross lottery sales for the year are approaching \$480 million, while net proceeds are expected to eclipse the record of \$101.7 million established in Fiscal Year 2021.

However, external economic factors will continue to impact the lowa Lottery as they do lowa household budgets and businesses. For example, the popular scratch-ticket category, which historically has been the most directly affected by higher fuel prices and inflationary pressures, lagged behind the previous year's results for the first half of FY 2023. But sales in those games have rebounded significantly over the final six months of the fiscal year.

Those pressures along with increased competition for consumer discretionary spending remain factors as the lowa Lottery approaches its next fiscal year.

The Lottery's staff and partners continue to work on game development and prize innovations to ensure the Lottery continues to meet the expectations of lowa consumers into the future.

This bi-annual Report on Operations details the Lottery's latest work in continuing to fulfill its role of responsibly generating revenues for important state causes.

# FY 2023 Lottery Product Sales



Through May, the latest month for which complete figures are available, annual lowa Lottery sales in FY 2023 totaled \$443.4 million, an 11.2 percent increase from the previous year's total for the same time period. Annual Lottery proceeds to state causes were \$101 million through May, up 12.6 percent from the total for the same time period in the previous year.

Prizes to players during the first 11 months of the fiscal year totaled \$280.3 million, while lottery sales commissions to lowa businesses totaled \$28.8 million for the time period, with both figures up more than 10 percent from the year before. Also of note, the Lottery's operational expenses remained about \$1.4 million under budget through May 2023, and up only 2.6 percent from the previous year.

Lotto games and scratch tickets continue as the Lottery's leading product categories. And although scratch-game sales saw a slight overall annual decrease through May, sales of those games had rebounded from earlier in the fiscal year, when fuel prices and inflationary factors were high. Scratch-ticket sales are expected to hold steady or be down slightly overall in FY 2023.

Meanwhile, lotto sales saw a big lift as the jackpots in Powerball® and Mega Millions® both climbed into the stratosphere during the fiscal year. The Powerball jackpot hit a world-record \$2.04 billion before it was won in that game's drawing on November 7, while the Mega Millions jackpot topped \$1.3 billion before it was won on January 13.

The lowa Lottery continues to work with other lotteries around the country to proactively explore ideas that could expand the pool of eligible players, control operational costs and increase lotto sales through jackpot growth. The lowa Lottery also will continue its own efforts to produce innovative products, responsible promotions and efficient operations that will allow it to remain a meaningful source of proceeds for state causes in lowa.

Historically, Lottery sales and proceeds results fluctuate from year to year based upon the strength of sales in particular product categories. The lowa Lottery bases its revenue projections on a five-year rolling average to best provide estimates that it can reliably achieve.

As always, the Iowa Lottery continuously monitors its sales results and will keep the Government Oversight Committees apprised of significant developments. The Lottery also provides regular updates regarding sales and proceeds through the State of Iowa's I-3 accounting system. The Lottery's latest monthly financial statement for May 2023 is included in this report as **Attachment A**.

#### FY 2024 Budget Approval

The Iowa Lottery's FY 2024 budget received final approval from the Iowa Lottery Board at its June 29 meeting.

Increases in sales, prizes, retailer compensation and proceeds along with retailer system costs were made to the budget to reflect the continued growth in sales for Lottery products. Shipping costs for the delivery of scratch tickets also were increased to reflect increased sales of that product category and increased costs for the service. The Lottery's net assets also were adjusted to reflect the anticipated purchase of additional self-service kiosks for Lottery sales in retail locations.

### Responsible Gambling

The lowa Lottery secured a record level of support this spring for its annual public-service campaign to highlight the help available in lowa for those impacted by problem gambling.

Each March, the Iowa Lottery works with the Problem Gambling Services Program within the Iowa Department of Health and Human Services on this public-service campaign in support of National Problem Gambling Awareness Month.

Throughout March 2023, a 30-second public-service announcement produced by the Lottery aired statewide on radio, streaming services, broadcast television and cable television. The combined total media value for the 2023 campaign was more than \$450,000, a record total for this awareness effort.

The lowa Lottery believes that utilizing a broad range of placements for its problem-gambling messages is critical to reaching lowans in all demographic groups to ensure they know where they can find help for themselves or a loved one.

In addition to this annual March campaign, the lowa Lottery provides consumers with ongoing responsible play messages throughout the year in a variety of ways. Those include 1-800-BETS OFF details on the tickets, brochures, point-of-sale materials and other publications it prints, through messaging on its Lottery terminals and self-service kiosks. #### **Change In Prize-Claim Period For Four Lotto Games**









In late April, the prize-claim period was changed for tickets purchased in Iowa in the Powerball, Mega Millions, Lotto America, and Lucky for Life games.

The Lottery Board voted in December to change the rules in the four games to require that Iowa prizes be claimed within 180 days of the drawing for which the winning tickets were eligible. The previous Iowa prize-claim period in those games was 365 days, the longest in the United States and outside the norm for the U.S. lottery industry.

The effort is designed to align lowa Lottery procedures with current industry standards and encourage players to claim prizes in an expeditious manner.

The change has no monetary benefit to the Iowa Lottery: Under state law, the money from prizes that expire in Iowa without being claimed go back to players through the Lottery's prize pools for future games and promotions. In the past three fiscal years, the annual total in Lottery prizes that expired in Iowa without being claimed ranged from about \$1.3 million to more than \$1.7 million.

lowa was one of only 14 states that allowed 365 days for a player to claim a prize in a multi-jurisdictional lotto game. By contrast, 33 jurisdictions (including the three most populous U.S. states) require those prizes to be claimed within 180 days or six months (182 days).

The change that took effect in April was made after analysis of prizes that expired in lowa without being claimed. A review of recent drawings in the four games found that the vast majority of prizes were claimed within the first six months. In fact, less than 3 percent of prizes from those drawings were claimed after 180 days.

The prize-claim change will hopefully mean that the maximum number of prizes won are claimed in the games.

lowa Code section 99G.31(3)(d) requires the Lottery to use unclaimed prizes (prizes not claimed within the prize claim period) for future prizes or special prize promotions. With the prize-claim change, the money from unclaimed prizes will more quickly be returned to Lottery players while new promotions can generate revenue for important state causes.

Additionally, time is an important consideration from a security perspective. As time passes, it becomes more difficult for those involved to accurately recall the details of a ticket purchase and provide that information to the lowa Lottery for verification purposes.

Here are the details that currently apply to lowa tickets for multi-jurisdictional games:

- <u>In Mega Millions:</u> Tickets purchased for the April 21 drawing or before have a prize-claim deadline of 365 days from the drawing. Beginning with tickets purchased on April 22, the prize-claim deadline is 180 days from the date of the drawing.
- In Powerball, Lotto America and Lucky for Life: Tickets purchased for the April 22 drawing or before have a prize-claim deadline of 365 days from the drawing. Beginning with tickets purchased on April 23, the prize-claim deadline is 180 days from the date of the drawing.

The prize-claim periods in the lowa Lottery's other games are unchanged:

- Tickets in Iowa-specific lotto games (Pick 3 and Pick 4) are valid for 90 days from the date of the drawing.
- Tickets in scratch games are valid for 90 days after the announced end of the game.
- Tickets in pull-tab games are valid for 90 days after the announced end of the game.
- Tickets in InstaPlay games are valid for 90 days from the date of purchase.

#### **Lottery Security-Compliance Reviews At Retail**



The Iowa Lottery's Security Department continues to make unannounced security checks at retail locations across the state to ensure that winning tickets are being handled appropriately by retail licensees and the placement of Lottery equipment is in compliance with Lottery requirements.

During the compliance checks, undercover lowa Lottery investigators visit retail locations and pose as customers presenting Lottery tickets for validation and payment.

In FY 2023, the Lottery has met its annual performance target for its investigators to conduct compliance checks in at least 20 percent of the 2,500 retail locations that are licensed to sell lowa Lottery products.

## **\$1 Million Prize Unclaimed In Ames**

A \$1 million Mega Millions prize remains unclaimed in Ames after nine months, and the lowa Lottery reminds its players to double-check their tickets.

The \$1 million-winning Mega Millions ticket was purchased at the Filling Station/Gateway Expresse, 2400 University Blvd. in Ames, for the game's drawing on September 6, 2022. It was the only ticket in



the country that night to match the five white balls but miss the yellow Mega Ball to win at the game's second prize level.

The winner or winners of the \$1 million prize have until the close of business on September 6, 2023, to claim it at Iowa Lottery headquarters in Clive.

## **Year-End Flurry Of Winners**



Demonstrating the random nature of lottery games, FY 2023 ended with a flurry of major wins by Iowa Lottery players.

In a five-day span in late June, four large prizes were won in four different Lottery games. The first was a \$1 million Mega Millions prize won June 23 in Davenport. Then on June 24, an InstaPlay jackpot of nearly \$400,000 was won in Cascade and a Powerball prize of \$2 million was won in Ottumwa. And on June 27, a prize of \$25,000 a year for life was won in the Lucky for Life game.

The winning streak is a real-world display of the detail so often emphasized by the lowa Lottery: You never know when or where the next big winner will hit.
