Section 1. Section 123.49, subsection 2, Code 2005, is 2 amended by adding the following new paragraph: NEW PARAGRAPH. 1. Sell, give, or otherwise supply to any 4 person an alcoholic beverage which is designed to be consumed 5 in a vaporized form. EXPLANATION This bill prohibits a person or club holding a liquor 8 control license or retail wine or beer permit, or their agents 9 or employees, from selling, giving, or providing an alcoholic 10 beverage in a vaporized form. Pursuant to the provisions of 11 Code section 123.50, a violation of the provisions of the bill 12 is a simple misdemeanor and is grounds for the revocation or 13 suspension of the person's license or permit.
