     This bill appropriates $1.06 million from the rebuild Iowa

21 belong to the association of Iowa fairs. Any unencumbered or
22 unobligated moneys remaining at the end of the fiscal year
23 shall not revert to the rebuild Iowa infrastructure fund, but
24 shall remain available for expenditure during the following
25 fiscal year for purposes of county fair infrastructure
