Section 1. Section 422.7, Code Supplement 2005, is amended 2 by adding the following new subsection: 45. Subtract, to the extent included, NEW SUBSECTION. 4 active duty pay received by a person as a member on federal 5 active duty of the armed forces or as a member in the armed 6 forces military reserve or national guard serving on federal 7 active duty other than for training. Sec. 2. RETROACTIVE APPLICABILITY DATE. This Act applies 9 retroactively to January 1, 2006, for tax years beginning on 10 or after that date. 11 **EXPLANATION** 12 This bill exempts active duty pay for members of the armed 13 forces, armed forces military reserve, and national guard who 14 serve on federal active duty other than for training. Description

Senate File 2160 excludes pay received for active military duty from the State income tax. The exclusion applies to members of the U.S. armed forces, armed forces reserve, and National Guard. The Bill is retroactive to tax years beginning on or after January 1, 2006.

Assumptions

- 1. There are 1,500,000 U.S. military personnel, and 0.85% (12,750) are lowans.
- 2. Of the U.S. military personnel, 150 are stationed in lowa and therefore, lowa taxpayers.
- 3. Of the remaining Iowa U.S. military personnel, 15.0% are currently Iowa taxpayers (1,890). The remaining personnel are residents of other states for tax purposes or are exempt from income tax due to war zone duty.
- 4. There are 1,200 Iowa National Guard and 465 Iowa Military Reserve personnel on active duty.
- 5. The National Guard and Military Reserve personnel will be on active duty 12 months of calendar year 2006 and five months of calendar year 2007. U.S. military personnel are always on active duty.
- 6. Of the active duty National Guard and Military Reserve personnel, 25.0% are residents of other states for tax purposes or are exempt from income tax due to war zone duty.
- 7. The average monthly pay for FY 2006 will be \$2,800 and increase 3.5% per year.
- 8. The average income tax rate for active military personnel will be 4.5%.
- 9. Income tax withholding payments prior to July 1, 2006, will not be impacted.

Fiscal Impact

The income tax exclusion included in SF 2160 will reduce State income taxes owed by active duty military personnel by the following amounts:

- FY 2007 \$4.9 million
- FY 2008 \$4.0 million
- FY 2009 \$3.2 million

The exclusion from taxable income will also reduce the local option income surcharge tax. The surcharge is a percentage of lowa tax liability and equals approximately 3.0% of total State income tax revenue. Revenue from the surcharge is distributed to schools. The surtax reduction is estimated as follows.

- FY 2007 \$147,000
- FY 2008 \$119,000
- FY 2009 \$100,000
