## A BILL FOR

- 1 An Act providing for exemptions related to the solemnization
- 2 or validity of a marriage based on sincerely held religious
- 3 beliefs.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. NEW SECTION. 595.21 Exemptions related to
- 2 solemnization or recognition of the validity of a marriage.
- An individual, religious or denominational organization,
- 4 or a charitable or educational organization operated,
- 5 supervised, or controlled by or connected with a religious or
- 6 denominational organization, shall not be liable, penalized, or
- 7 denied benefits under the laws of this state or any political
- 8 subdivision of this state, including but not limited to
- 9 laws regarding employment discrimination, housing, public
- 10 accommodations, licensing, government contracts or grants, or
- 11 tax-exempt status, for refusing to solemnize any marriage,
- 12 for refusing to provide services, accommodations, advantages,
- 13 facilities, goods, or privileges related to the solemnization
- 14 of any marriage, or for refusing to treat as valid any
- 15 marriage, if such providing, solemnizing, or treating as valid
- 16 would cause such individual or organization to violate the
- 17 sincerely held religious beliefs of the individual or to which
- 18 the organization subscribes.
- 19 2. The exemptions provided pursuant to subsection 1 shall
- 20 not apply if either of the following conditions exists:
- 21 a. A government employee shall not refuse to assist in the
- 22 solemnization of any marriage under this section if another
- 23 government employee is not available and willing to so assist.
- 24 b. A refusal to provide services, accommodations,
- 25 advantages, facilities, goods, or privileges related to the
- 26 solemnization of any marriage shall not be protected under
- 27 this section if a party to the marriage is unable to obtain
- 28 any similar services, accommodations, advantages, facilities,
- 29 goods, or privileges elsewhere, and such inability to obtain
- 30 such similar services, accommodations, advantages, facilities,
- 31 goods, or privileges elsewhere constitutes a substantial
- 32 hardship.
- 33 EXPLANATION
- 34 This bill provides exemptions to certain individuals and
- 35 organizations related to solemnization and recognition of the

1 validity of marriages.

2 The bill provides that an individual, religious or 3 denominational organization, or a charitable or educational 4 organization operated, supervised, or controlled by or 5 connected with a religious or denominational organization, 6 shall not be liable, penalized, or denied benefits under 7 the laws of this state or any political subdivision of this 8 state, including but not limited to laws regarding employment 9 discrimination, housing, public accommodations, licensing, 10 government contracts or grants, or tax-exempt status, for ll refusing to solemnize any marriage, for refusing to provide 12 services, accommodations, advantages, facilities, goods, or 13 privileges related to the solemnization of any marriage, or for 14 refusing to treat as valid any marriage, if such providing, 15 solemnizing, or treating as valid would cause such individual 16 or organization to violate the sincerely held religious beliefs 17 of the individual or to which the organization subscribes. 18 However, the exemptions do not apply; or in the case in which 19 a government employee refuses to assist in the solemnization 20 of a marriage, if another government employee is not available 21 and willing to so assist if the refusal to provide services, 22 accommodations, advantages, facilities, goods, or privileges 23 related to the solemnization of any marriage results in a party 24 to the marriage being unable to obtain any similar services, 25 accommodations, advantages, facilities, goods, or privileges 26 elsewhere, and this constitutes a substantial hardship.
