## A BILL FOR

- 1 An Act relating to indemnification of hospitals participating
- in the volunteer health care provider program.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

## H.F. 203

- 1 Section 1. Section 135.24, subsection 2, paragraphs b and c,
- 2 Code 2011, are amended to read as follows:
- 3 b. Procedures for registration of hospitals, free clinics,
- 4 field dental clinics, and specialty health care provider
- 5 offices.
- 6 c. Criteria for and identification of hospitals, clinics,
- 7 free clinics, field dental clinics, specialty health care
- 8 provider offices, or other health care facilities, health
- 9 care referral programs, or charitable organizations,
- 10 eligible to participate in the provision of free medical,
- 11 dental, chiropractic, pharmaceutical, nursing, optometric,
- 12 psychological, social work, behavioral science, podiatric,
- 13 physical therapy, occupational therapy, respiratory therapy,
- 14 or emergency medical care services through the volunteer
- 15 health care provider program. A hospital, a clinic, a
- 16 free clinic, a field dental clinic, a specialty health care
- 17 provider office, a health care facility, a health care referral
- 18 program, a charitable organization, or a health care provider
- 19 participating in the program shall not bill or charge a
- 20 patient for any health care provider service provided under the
- 21 volunteer health care provider program.
- Sec. 2. Section 135.24, Code 2011, is amended by adding the
- 23 following new subsection:
- 24 NEW SUBSECTION. 6A. A hospital providing free care under
- 25 this section shall be considered a state agency solely for
- 26 the purposes of this section and chapter 669 and shall be
- 27 afforded protection under chapter 669 as a state agency for
- 28 all claims arising from the provision of free care by a health
- 29 care provider registered under subsection 3 who is providing
- 30 services at the hospital in accordance with this section or
- 31 from the provision of free care by a health care provider
- 32 who is covered by adequate medical malpractice insurance, as
- 33 determined by the department, if the hospital has registered
- 34 with the department pursuant to subsection 1.
- 35 Sec. 3. Section 135.24, subsection 7, Code 2011, is amended

## H.F. 203

- 1 by adding the following new paragraph:
- 2 NEW PARAGRAPH. Oe. "Hospital" means hospital as defined in
- 3 section 135B.1.
- 4 EXPLANATION
- 5 This bill relates to hospitals under the volunteer health
- 6 care provider program. The bill provides that a hospital
- 7 providing free care under the program is considered a state
- 8 agency solely for the purposes of the program and Code chapter
- 9 669 (state tort claims Act) and is to be afforded protection
- 10 under Code chapter 669 as a state agency for all claims arising
- 11 from the provision of free care by a health care provider
- 12 registered under the program who is providing services at
- 13 the hospital in accordance with the program, and also is
- 14 afforded protection for the provision of free care by a health
- 15 care provider who is covered by adequate medical malpractice
- 16 insurance if the hospital has registered with the department of
- 17 public health as required under the program.
