A BILL FOR

- 1 An Act providing deductions from the individual and corporate
- 2 income taxes for expenses incurred by medical cannabidiol
- 3 manufacturers, and including effective date and retroactive
- 4 applicability provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 422.7, Code 2020, is amended by adding
- 2 the following new subsection:
- 3 NEW SUBSECTION. 59. Subtract, to the extent included,
- 4 the amount of business expense for a medical cannabidiol
- 5 manufacturer licensed pursuant to chapter 124E without regard
- 6 to section 280E of the Internal Revenue Code.
- 7 Sec. 2. Section 422.35, Code 2020, is amended by adding the
- 8 following new subsection:
- 9 NEW SUBSECTION. 26. Subtract, to the extent included,
- 10 the amount of business expense for a medical cannabidiol
- 11 manufacturer licensed pursuant to chapter 124E without regard
- 12 to section 280E of the Internal Revenue Code.
- 13 Sec. 3. EFFECTIVE DATE. This Act, being deemed of immediate
- 14 importance, takes effect upon enactment.
- 15 Sec. 4. RETROACTIVE APPLICABILITY. This Act applies
- 16 retroactively to January 1, 2020, for tax years beginning on
- 17 or after that date.
- 18 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 21 This bill provides deductions from the individual and
- 22 corporate income taxes for business expenses incurred by
- 23 medical cannabidiol manufacturers.
- 24 Under federal law, a medical cannabidiol manufacturer is
- 25 prohibited from taking business expense deductions by section
- 26 280E of the Internal Revenue Code. Currently, Iowa computes
- 27 individual net income and corporate taxable income based upon
- 28 federal income calculations, and therefore Iowa currently
- 29 prohibits a medical cannabidiol manufacturer from taking
- 30 business expense deductions as well because the deductions are
- 31 not allowed at the federal level.
- 32 The bill allows a medical cannabidiol manufacturer licensed
- 33 pursuant to Code chapter 124E to deduct business expenses for
- 34 purposes of the Iowa individual income tax or corporate income
- 35 tax.

- 1 The bill takes effect upon enactment and applies
- 2 retroactively to tax years beginning on or after January 1,
- 3 2020.
