






# About The DOC

## IOWA JUDICIAL DISTRICTS AND INSTITUTIONS




## About The DOC

## 905.2 District departments established.

...Each district department shall furnish or contract for those services necessary to provide a community-based correctional program which meets the needs of that judicial district. The district department is under the direction of a board of directors, selected as provided in section 905.3, and shall be administered by a director employed by the board. A district department is a state agency for purposes of chapter 669.



## About Governor's FY2024 Budget Recommendations

#### Pharmacy Increases:

• Transfer \$243,797 from Department Wide Duties

• Increase \$750,000 for Hepatitis C Treatment

## About Recidivism Rates

#### **Three-Year Recidivism Trends**

Over the course of the last two years, the recidivism rate has decreased by 2.6%

FY2022 ▼37% FY2021 ▼38.7%

**FY2020** ▼39.6% Succssful Reentry Rate

In FY22, 63% of those who were released from prison three-years earlier, successfully reentered the community and did not return to prison. 63%



## About Security Improvements

- Addition of body scanners at several facilities
- Use of body cameras
- Enhanced security audit process for all facilities.
- Conducted Security Auditor Training through National Institute of Corrections, adding 25 Certified Auditors
- Two Compliance Officers monitoring security compliance throughout the prison facilities

## About Data Driven Decisions DOC Dashboards and Analytics

#### Prison Alert Dashboard:

Utilizes a violence prediction model to determine an individual's assault risk while incarcerated; enhancing the safety and security of both correction's staff and individuals incarcerated

#### Early Alert Dashboard:

Utilizes a risk prediction algorithm developed from years of Iowa community corrections' data, to flag individuals who have a high assaultive risk as well as those who are generally at risk for community supervision failure

\*The intent of both alert dashboards are to deploy added interventions and support services to help stabilize individuals at risk

## About Data Driven Decisions DOC Dashboards and Analytics

#### Medical Outbreak Management Dashboard:

For the institutions' medical teams to help better manage, track, and analyze communicable disease trends of those incarcerated

#### Release Candidates Dashboard:

Created to help correctional staff identify clients who may be appropriate candidates for BOP review and institutional release

# Non-Legal Mail Scanning Service Pigeonly

#### Purpose:

• Curtail the introduction of contraband through non-legal mail

#### Impacts:

- No cost to friends and family to send non-legal mail through Pigeonly
- Significant reduction in contraband introduction



## Treatment Pilot Project Tech2Connect

#### Purpose:

 Increase the number of individuals who received evidence-based cognitive treatment and increase the dosage of evidence based cognitive programming received

#### Impacts:

- 1,000 individuals have been served by the program
- CBC districts utilized tablets and technology to connect with individual incarcerated prior to release to begin the reentry process

## About Our Apprenticeship Program Study

This study showed that those who completed an apprenticeship program:

- were less likely to return to prison
- were more likely to find work
- received higher wages

## About The Alignment Bill

#### Merges Community Based Corrections (CBCs) into the Department of Corrections

- The Director of the DOC assumes management and oversight of the CBC Districts, creating a single corrections continuum
- The District Boards will remain in an advisory capacity
- Drives operational consistency to decrease recidivism and increase public safety
- 80% of CBC funding comes from the General Fund; the remaining 20% is from fees collected from clients
