## INTRODUCTION OF BILLS

[House File 2038](#), by committee on ways and means, a bill for an act relating to the phaseout of the sales and use taxes on the sale and furnishing of gas, electricity, and fuel to residential customers.

Read first time and placed on the **ways and means calendar**.

[House File 2039](#), by committee on appropriations, a bill for an act relating to the state general fund expenditure limitation by revising the percentage amount used for the limitation and including effective date and applicability provisions.

Read first time and placed on the **appropriations calendar**.

[House File 2040](#), by Sands, a bill for an act requiring daytime running lights on new motor vehicles sold in Iowa, making a penalty applicable, and providing an effective date.

Read first time and referred to committee on **transportation**.

Read first time and referred to committee on **local government**.
