

# A BILL

FOR AN ACT TO ACCEPT AND LEGALIZE THE GRANT TO THE STATE OF IOWA, MADE BY THE CITY OF IOWA CITY, OF CERTAIN RIGHTS AND PRIVILEGES IN A PUBLIC PARK AND STREET IN SAID CITY, AS INDICATED BY AN ORDINANCE OF SAID CITY, PASSED MARCH 7, 1890.

1 WHEREAS, The city of Iowa City has passed and ordained the following ordinance, to-wit:

## AN ORDINANCE

3 Granting the use of the Public Park of Iowa City, and Vacating and Granting Linn Street,  
4 Between Jefferson Street and Iowa Avenue, to the State of Iowa, for the use of the Iowa  
5 State University :

6 Section 1. Be it ordained by the city council of the city of Iowa City, that the use of the  
7 public park of Iowa City, said park being located between Dubuque and Linn streets and be-  
8 tween Iowa avenue and Jefferson street, is hereby granted to the state of Iowa for the use of  
9 the Iowa state university, said park to be used by the state of Iowa for the purpose of erect-  
10 ing thereon additional buildings to be used by the Iowa state university.

11 Sec. 2. All that part of Linn street located between Iowa avenue and Jefferson street is  
12 hereby vacated, and the use of the same granted to the state of Iowa for the use of the Iowa  
13 state university, the said street so vacated to be used in connection with the park hereinbefore  
14 granted.

15 Sec. 3. The city of Iowa City to retain the proprietorship, control, and preservation of  
16 the park and street named in said grant for the free use of the public, until such time as the  
17 state of Iowa shall need the same for the erection of suitable buildings thereon, said building  
18 to be used exclusively by the state university of Iowa for educational purposes.

19 Sec. 4. Should the state, after occupying said premises, fail to use said property for the  
20 purposes herein designated and specified, then the grant herein made to be void, and said  
21 property to revert to Iowa City for the use of the public.

*Be it enacted by the General Assembly of the State of Iowa:*

SECTION 1. That the action of said city of Iowa City in passing said ordinance, be, and the same is hereby legalized and confirmed, and the same made effectual and valid.

SEC. 2. That the grant in said ordinance made to the state of Iowa, of the use and benefit of the public park and street in said ordinance described, be, and the same is hereby accepted by the state of Iowa, subject to the terms and conditions in said ordinance mentioned, and for the use and benefit of the state university of Iowa.
