

# A BILL

FOR AN ACT TO AMEND THE LAW AS IT APPEARS IN SECTIONS TWENTY-SEVEN HUNDRED THIRTY-NINE (2739); TWENTY-SEVEN HUNDRED FIFTY-SEVEN (2757); TWENTY-SEVEN HUNDRED SIXTY-TWO (2762); TWENTY-SEVEN HUNDRED SIXTY-FOUR (2764); TWENTY-SEVEN HUNDRED SIXTY-FIVE (2765); TWENTY-SEVEN HUNDRED SIXTY-NINE (2769); TWENTY-SEVEN HUNDRED SEVENTY-THREE (2773); TWENTY-SEVEN HUNDRED EIGHTY-FIVE (2785); AND TWENTY-EIGHT HUNDRED ONE (2801) OF THE CODE, AND SECTION TWENTY-SEVEN HUNDRED FIFTY-FOUR (2754), OF THE SUPPLEMENT TO THE CODE AND TO REPEAL SECTION TWENTY-SEVEN HUNDRED NINETY-THREE (2793) OF THE CODE AND ENACT A SUBSTITUTE THEREFOR, RELATIVE TO THE SCHOOL YEAR, ORGANIZATION AND MEETINGS OF THE SCHOOL BOARDS, REPORTS OF SCHOOL OFFICERS AND CHANGING OF BOUNDARIES OF SCHOOL CORPORATIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. That section twenty-seven hundred thirty-nine (2739) of the code be and the same is hereby amended by striking out the words "first Tuesday in October" in the second line and inserting in lieu thereof the words "last Tuesday in August."

Section 2. That section twenty-seven hundred fifty-four (2754) of the supplement to the code be and the same is hereby amended by striking out the words "third Monday in March" in the nineteenth line and inserting in lieu thereof the words "first day of July, unless that date falls on Sunday, in which case on the day following."

Section 3. That section twenty-seven hundred fifty-seven (2757) of the code be and the same is hereby amended by striking out the word "September" in the second line and inserting in lieu thereof the words "the first day of July, unless that date falls on Sunday, in which case on the day following," and by striking out the word "September" in lines ten and fifteen of said section and inserting in lieu thereof in each of said lines the words "July."

Section 4. That section twenty-seven hundred sixty-two (2762) of the code be and the same is hereby amended by striking out the word "September" in line six and inserting in lieu thereof the word "July."

Section 5. That section twenty-seven hundred sixty-four (2764) of the code be and the same is hereby amended by striking out the words "September and the third Monday in

3 September" in line two and inserting in lieu thereof the words "June and first day of July."

Section 6. That section twenty-seven hundred sixty-five (2765) of the code be and the same  
2 is hereby amended by striking out the words "third Monday in September of" in the third line  
3 and inserting in lieu thereof the words "regular July meeting in."

Section 7. That section twenty-seven hundred sixty-nine (2769) of the code be and the  
2 same is hereby amended by striking out the words "on the third Monday of September" in the  
3 fourth line and inserting in lieu thereof the words "at its regular July meeting."

Section 8. That section twenty-seven hundred seventy-three (2773) of the code be and the  
2 same is hereby amended by striking out the words "third Monday in March" in lines ten and  
3 eleven and inserting in lieu thereof the words "first of July."

Section 9. That section twenty-seven hundred eighty-five (2785) of the code be and the  
2 same is hereby amended by striking out the words "tenth days of September" in the eighth  
3 line and inserting in lieu thereof the words "fifteenth days of June" and by striking out the  
4 word "fifteenth" in the tenth line and inserting in lieu thereof the word "twentieth."

Section 10. That section twenty-seven hundred ninety-three (2793) of the code be and the  
2 same is hereby repealed and the following enacted in lieu thereof: "The boundary lines of  
3 contiguous school corporations in the same county may be changed by the concurrent action  
4 of the respective boards of directors at their regular meetings in July, or at a special meeting  
5 thereafter called for that purpose. The corporation from which territory is detached shall  
6 after the change contain not less than four government sections of land, and its boundary  
7 lines must conform to the lines of congressional divisions of land. In the same manner, the  
8 boundary lines of contiguous school corporations in the same county may be so changed that  
9 one corporation shall be included in and consolidated with the other as a single corporation."

Section 11. That section twenty-eight hundred one (2801) of the code be and the same is  
2 hereby amended by striking out the word "September" in line three and inserting in lieu  
3 thereof the word "July."

Section 12. This act being deemed of immediate importance, shall be in full force and  
2 effect on and after its publication in the Register and Leader and Des Moines Capital, news-  
3 papers published in Des Moines, Iowa.
