

A BILL

FOR AN ACT APPROPRIATING THE SUM OF \$278.21 (TWO HUNDRED SEVENTY-EIGHT DOLLARS, TWENTY-ONE CENTS) TO BE PAID TO CRAWFORD COUNTY IN SETTLEMENT OF CLAIMS AGAINST THE STATE OF IOWA BY REASON OF EXPENSE INCURRED IN THE TRANSPORTING OF RUSSELL GIFFORD AND WILLIAM BUTTORWORTH, INSANE PERSONS OUT OF THE STATE.

WHEREAS, on or about the twenty-fifth day of April, 1905, the Insane Commissioners of Crawford County, Iowa, declared one Russell Gifford insane, and found his residence in Benton County, Oregon, and said Commissioners ordered the sheriff of Crawford County to deliver the said Russell Gifford to proper authorities in Benton County, Oregon; and,

WHEREAS, on the thirteenth day of January, 1905, the Insane Commissioners of Crawford County, Iowa, adjudged one William Buttorworth, in said County, to be insane and found his residence to be in the state of Wisconsin, and that he had escaped from the Insane Hospital at Appleton, Wisconsin, and said Insane Commissioners ordered the Sheriff of Crawford County, Iowa, to deliver said William Buttorworth to the Hospital for insane at Appleton, Wis., and,

WHEREAS, said sheriff in conducting said Russell Gifford to Benton County, Oregon, and the said William Buttorworth to Appleton, Wis., incurred an expense, which was allowed and paid by the Board of Supervisors of Crawford County, Iowa: Therefore;

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. That there is hereby appropriated out of any money in the State Treasury, not otherwise appropriated, the sum of \$278. 21 (two hundred seventy-eight dollars twenty-one cents) as payment in full of all claims against the State of Iowa, on account of expense incurred in transporting Russell Gifford from Crawford County, Iowa, to Benton County, Oregon as follows:

Railroad fare for patient and sheriff to Corvallis, Oregon, and return of sheriff to Denison, Iowa.....	\$100.61
Board and lodging and sleeping berth for patient and sheriff in delivering patient to Oregon.....	37.50
Hack hire, while delivering patient.....	3.50

11 Sheriff fee for delivering patient, five days at \$3.00 per day..... 15.00

12 Total..... \$156.61

15 Railroad fare for sheriff, assistant and patient to Appleton, Wisconsin,
