

# A BILL

FOR AN ACT TO AMEND THE LAW AS IT APPEARS IN SECTIONS TEN HUNDRED EIGHTY-SEVEN-a1 (1087-a1), TEN HUNDRED EIGHTY-SEVEN-a4 (1087-a4), TEN HUNDRED EIGHTY-SEVEN-a10 (1087-a10), TEN HUNDRED EIGHTY-SEVEN-a20 (1087-a-20), TEN HUNDRED EIGHTY-SEVEN-a25 (1087-a25), TEN HUNDRED EIGHTY-SEVEN-a26 (1087-a26) AND TEN HUNDRED EIGHTY-SEVEN-a27 (1087-a27) OF THE SUPPLEMENT TO THE CODE, 1907, PROVIDING FOR THE NOMINATION OF JUDGES OF THE SUPREME AND DISTRICT COURTS AT THE REGULAR PRIMARY ELECTION.

*Be it Enacted by the General Assembly of the State of Iowa:*

SECTION 1. The law as it appears in section ten hundred eighty-seven-a1 (1087-a1), Supplement to the Code, 1907, is hereby amended by striking out the words, "supreme, district and" from lines four and five of said section, and by striking out the letter "s" from the word "courts" in said line five.

SEC. 2. The law as it appears in section ten hundred eighty-seven-a4 (1087-a4), Supplement to the Code, 1907, is hereby amended by striking from line seven thereof the words, "supreme, district and" and by striking the letter "s" from the word "courts" in said line.

SEC. 3. The law as it appears in section ten hundred eighty-seven-a10 (1087-a10), Supplement to the Code, 1907, is hereby amended by inserting the words, "judge of the district court" followed by a comma, immediately after the comma following the word "States," and before the word "or" in line seven of said section, and by inserting the words, "judge of the district court" followed by a comma, immediately after the comma following the word "elector" and before the word "or" in line one of paragraph two of said section.

SEC. 4. The law as it appears in section ten hundred eighty-seven-a20 (1087-a20), Supplement to the Code, 1907, is hereby amended by inserting as line nine of said section the following: "Judge of the district court."

SEC. 5. The law as it appears in section ten hundred eighty-seven-a25 (1087-a25) of the Supplement to the Code, 1907, is hereby amended by striking out that part thereof beginning with the word "and" in line eleven from the bottom of said section and ending with the word "state" and the comma immediately following, in line nine from the bottom of said section;

5 and by striking out the words "except judicial conventions" and the comma immediately fol-  
6 lowing the same, in line four from the bottom of said section.

SEC. 6. The law as it appears in section ten hundred eighty-seven-a26 (1087-a26), Supple-  
2 ment to the Code, 1907, is hereby amended by striking out the comma in line five of said sec-  
3 tion, and the words, "and a judicial convention shall be held" in lines five and six thereof,  
4 and by inserting a comma after the word "senatorial" in lines four and five of said section,  
5 and inserting the word "judicial" immediately following said comma, and by inserting the  
6 words, "or judge of the district court" between the word "assembly" and the second word  
7 "in" in line sixteen from the bottom of said section.

SEC. 7. The law as it appears in section ten hundred eighty-seven-a27 (1087-a27), Supple-  
2 ment to the Code, 1907, is hereby amended by striking out the semi-colon in line eight from  
3 the bottom of said section, and also the words, "and shall nominate candidates for the office  
4 of judge of the supreme court" from said line eight and the following line.
