

## A BILL FOR AN ACT

To amend the law as it appears in sections forty-nine hundred ninety-nine-a25 (4999-a25) and forty-nine hundred ninety-nine-a31b (4999-a31b), supplement to the code, 1913, and section forty-nine hundred ninety-nine-a31f (4999-a31f), supplemental supplement to the code, 1915, relating to the impersonation of the Dairy and Food Commissioner, his assistants or inspectors, and providing a penalty therefor; compensation of inspectors or assistants; and to the appropriation for enforcing the provisions of the various laws; the enforcement of which is vested with the state dairy and food commissioner.

*Be it Enacted by the General Assembly of the State of Iowa:*

1 Section 1. That the law as it appears in section forty-nine  
2 hundred ninety-nine-a25 (4999-a25), supplement to the code, 1913,  
3 be and the same is hereby amended by striking out the period following  
4 the word "dollars" in the seventh line thereof and substituting a comma  
5 therefor and by adding the following: "except that any person falsely  
6 assuming to be the dairy and food commissioner, the deputy dairy and  
7 food commissioner, an assistant dairy and food commissioner, or any  
8 other officer or inspector of the dairy and food department, and taking  
9 upon himself to act as such, shall be imprisoned in the county jail  
10 not more than thirty days or be fined not exceeding one hundred dollars."

1 Sec. 2. That the law as it appears in section forty-nine hundred  
2 ninety-nine-a31b (4999-a31b), supplement to the code, 1913, be and  
3 the same is hereby amended by striking out the sentence beginning with  
4 the word "They" in the ninth line thereof and substituting the follow-

5 ing in lieu thereof: "They shall be paid a salary of not to exceed the  
6 following: for the first year of service, fifteen hundred dollars,  
7 \$1500.00), for the second year of service, sixteen hundred dollars  
8 (\$1600.00), for the third and fourth years of service, eighteen  
9 hundred dollars (\$1800.00), and for the fifth year of service and  
10 each year thereafter, two thousand dollars (\$2000.00), said salaries  
11 to be paid in the same manner as the salaries of other state officers  
12 and they shall be allowed the expenses necessarily incurred by them  
13 in the discharge of their duties."

1 Sec. 3. That the law as it appears in section forty-nine hundred  
2 ninety-nine-a31f (4999-a31f), supplemental supplement to the code,  
3 1915, be and the same is hereby amended by striking out the word  
4 "thirty-four" in the seventh line thereof and substituting the word  
5 "thirty-eight" therefor.

1 Sec. 4. That this act being deemed of immediate importance shall  
2 take effect and be in full force from and after its publication in  
3 the Des Moines Capital, a newspaper published in the city of Des Moines,  
4 Iowa, and in the Burlington Hawkeye, a newspaper published in the city  
5 of Burlington, Iowa
