A BILL FOR AN ACT

Legalizing the formation and establishment and proceedings of the independent school district of Bode, in Humboldt county, Iowa.

Whereas, the independent school district of Bode, in Humboldt county, state of Iowa, as now formed and established is comprised of the following described territory, to-wit:

All of the incorporated town of Bode, Iowa, and the territory contiguous thereto and described as follows: All that part of sections sixteen, seventeen, twenty and twenty-one, not included within the limits of the incorporated town of Bode, Iowa; the west half of section three; all of sections four, five, six, seven, eight and nine; the south half and the northwest quarter of section ten; the southeast quarter of section eleven; west half of section fourteen; all of sections fifteen and eighteen; east half and northwest quarter of section nineteen; the west half and the west half of the east half of section twenty-two; the north half of the northwest quarter of section twenty-seven; north half of section twenty-eight; north half of section twenty-nine and the northeast quarter of section thirty, all in township ninety-three north, range twenty-nine, west of the fifth p. m. Iowa; and the southeast quarter of section thirteen, in township ninety-three, north range thirty, west of the fifth p. m. Iowa; and all in Humboldt county, state of Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. That all of the acts and proceedings of
2 the independent school district of Bode, Iowa, and of the board
3 of directors of said school district, and the election held in
4 said school district on the 25th day of June, 1918, which acts
5 and proceedings resulted in the formation and establishment of
6 the independent school district of Bode, Iowa, and the election

7 held in said school district on the 17th day of July, 1918,
8 for the election of a board of directors and other officers
9 in said school district, and the acts of the board of direc-
10 tors in said school district in changing the boundary lines
11 between said school district and the consolidated independ-
12 ent school district of Ottosen, in Humboldt and Kossuth
13 counties, in the state of Iowa, and the action of the board of
14 directors of said district in changing the boundary lines be-
15 tween said school district and Maple Lawn rural independent
16 school district, in Wacousta township, in Humboldt county,
17 state of Iowa, be and the same are hereby declared legal and
18 valid, and the formation and establishment of the independent
19 school district of Bode, in Humboldt county, in the state of
20 Iowa, as now formed and established, consisting of the above
21 described territory, be and hereby is declared legal and valid
22 in all respects the same as if all provisions of law relating
23 to the formation and establishment of independent school dis-
24 tricts and the changing of the boundary lines thereof had been
25 in all respects strictly complied with.

1 Sec. 2. Nothing in this act shall effect in any
2 way pending litigation in relation to the subject matter
3 hereof.

1 Sec. 3. This act being deemed of immediate
2 importance shall be in full force and effect from and after
3 its publication in the Des Moines Register, a newspaper pub-
4 lished at Des Moines, Iowa, and the Bode Bugle, a newspaper

5 published at Bode, in Humboldt county, Iowa, all without ex-
6 pense to the state of Iowa.
