## A BILL FOR

An Act to make an appropriation to Winnebago County, Iowa, Emmet County, Iowa, Louisa County, Iowa, Muscatine County, Iowa, and Hancock County, Iowa, for drainage and secondary road assessments.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated to Winnebago  
2 County, Iowa, the sum of sixty-three dollars and ninety-  
3 eight cents (\$63.98) for special assessment on drainage  
4 district number two (2) at Winnebago County, Iowa, on  
5 account of real estate owned by the state of Iowa at Rice  
6 Lake state park in said county.

1 Sec. 2. There is hereby appropriated to Hancock County,  
2 Iowa, the sum of six hundred thirty dollars and twenty-  
3 seven cents (\$630.27) in payment of special drainage  
4 assessments levied upon lands owned by the state of Iowa  
5 at Pilot Knob state park.

1 Sec. 3. There is hereby appropriated to Emmet County,  
2 Iowa, the sum of thirteen hundred seventy-eight dollars and  
3 ninety-six cents (\$1,378.96) in payment of special assessments  
4 upon property owned by the state of Iowa in drainage district  
5 number one hundred thirty-nine (139), secondary road graveling  
6 district number fifty (50), drainage district number seventeen  
7 (17) and secondary road graveling district number seventy-  
8 two (72) in said county.

1     Sec. 4. There is hereby appropriated to Louisa County,  
2 Iowa, the sum of twenty-one hundred thirty-four dollars and  
3 twelve cents (\$2,134.12) in payment of taxes due on property  
4 owned by the state of Iowa in drainage district number  
5 thirteen (13) of Muscatine and Louisa Counties, Iowa.

1     Sec. 5. There is hereby appropriated to Muscatine  
2 County, Iowa, the sum of fifty-four hundred twenty-four  
3 dollars and two cents (\$5,424.02) in payment of special  
4 assessments upon lands owned by the state of Iowa in  
5 drainage district number thirteen (13) of Louisa and  
6 Muscatine Counties, Iowa.

1     Sec. 6. The auditor of state is hereby authorized and  
2 directed to draw his warrants to the respective counties  
3 in the sums hereinbefore set out in payment of said taxes,  
4 and the treasurer of state is hereby authorized and directed  
5 to pay the same out of any funds in the state treasury not  
6 otherwise appropriated.

1     Sec. 7. This act being deemed of immediate importance  
2 shall be in full force and effect from and after its  
3 publication as provided by law.
