An Act to legalize the corporate acts and proceedings of the Marshalltown

## A BILL FOR

Manufacturing Company of Marshalltown, Iowa and to provide for the renewal and extension of the period of corporate existence and the adoption of renewal, amended and substituted articles of incorporation of said Marshalltown Manufacturing Company.

WHEREAS, The period of corporate existence of Marshalltown Manufacturing Company, organized under the laws of the State of Iowa, with its principal place of business in the city of Marshalltown, Marshall County, Iowa, expired on the 12th day of September, 1932, and through inadvertence the same was not renewed within the period prescribed by statute; and

WHEREAS, The said Marshalltown Manufacturing Company continued thereafter to conduct its business and affairs as a corporation; and

WHEREAS, On the 11th day of September, 1932, at a special meeting of the stockholders of said corporation called for that purpose, the corporate period of said corporation was renewed for a period of twenty (20) years from the date of its expiration, and said stockholders adopted certain renewal, amended and substituted articles of incorporation; and

WHEREAS, On the 14th day of October, 1933, a certificate evidencing the renewal of the corporate existence of said corporation and the adoption of renewal, amended and substituted articles of incorporation was filed in the office of the Secretary of State of the State of Iowa, and provision duly made for the payment of the filing and recording fees provided by law, now, therefore,

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. All proceedings had with respect
- 2 to the renewal of the corporate existence of Marshalltown
- 3 Manufacturing Company and the adoption of renewal,
- 4 amended and substituted articles of incorporation be and
- 5 the same are hereby legalized and shall have the same
- 6 force and effect as if adopted pursuant to law within

7 the period prescribed by statute, and shall be held and  
8 considered as a renewal and extension of the period of  
9 corporate existence of said corporation, which expired  
10 September 12, 1932, and all the corporate acts and  
11 proceedings of said corporation subsequent to September  
12 12, 1932, including the proceedings in connection with  
13 the renewal and extension of the corporate existence  
14 of said corporation and the adoption of renewal, amended  
15 and substituted articles of corporation, are hereby  
16 declared to be valid and legal and to have the same force  
17 and effect as though said renewal and extension of the  
18 corporate existence had been consummated within the time  
19 prescribed by law.

20 The Secretary of State is hereby authorized  
21 and directed to issue to said Marshalltown Manufacturing  
22 Company a certificate of renewal of the corporate existence  
23 of said corporation, providing that the corporate exist-  
24 ence shall expire on the 12th day of September, 1952.  
25 Nothing in this act shall be deemed or construed to  
26 effect pending litigation.

1 Sec. 2. This act being deemed of immediate  
2 importance shall take effect and be in force from and  
3 after its publication in the Times-Republican, a news-  
4 paper published in the city of Marshalltown, Marshall  
5 County, Iowa, without expense to the State.
