## A BILL FOR

An Act to repeal sections fifty-two hundred twenty-one (5221), fifty-two hundred twenty-three (5223), fifty-two hundred twenty-five (5225), fifty-two hundred twenty-seven (5227), fifty-two hundred twenty-nine (5229), fifty-two hundred thirty-one (5231), and fifty-two hundred thirty-six (5236), code 1931, and enact substitutes therefor; and to amend sections fifty-one hundred twenty-five (5125), fifty-two hundred twenty (5220), fifty-two hundred twenty-two (5222), fifty-two hundred twenty-four (5224), fifty-two hundred twenty-six (5226), fifty-two hundred twenty-eight (5228), fifty-two hundred thirty (5230), fifty-two hundred thirty-two (5232), fifty-five hundred seventy-one (5571), fifty-five hundred seventy-two (5572), fifty-five hundred seventy-three (5573), and fifty-six hundred sixty-nine (5669), code 1931, revising statutory salaries of county officers and prescribing the method of fixing the salaries of their deputies.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. That section fifty-two hundred twenty-one  
2 (5221), fifty-two hundred twenty-three (5223), fifty-two hun-  
3 dred twenty-five (5225), fifty-two hundred twenty-seven (5227),  
4 fifty-two hundred twenty-nine (5229), fifty-two hundred thirty-  
5 one (5231), and fifty-two hundred thirty-six (5236), code 1931,  
6 be and the same are hereby repealed and the following enacted  
7 in lieu thereof:

8 "That the salaries of all Deputy Auditors, Deputy Treasurers,  
9 Deputy Recorders, Deputy Sheriffs, Assistant County Attorneys,  
10 Deputy Clerks of court, and all other deputy county officials  
11 shall be fixed by the Board of Supervisors."

1 Sec. 2. (Supervisors) Amend section fifty-one hundred

2 twenty-five (5125), code 1931, by striking from line three (3)  
3 the word "five" and substituting therefor the word "four".

4 Further amend said section by striking from line four  
5 (4) the word "five" and substituting therefor the word "four".

1 Sec. 3. (County Auditor) Amend section fifty-two hundred  
2 twenty (5220), code 1931, by striking from paragraph one (1)  
3 line one (1) the words "seventeen hundred" and substituting  
4 therefor the words "fourteen hundred forty-five".

5 Further amend said section by striking from paragraph

4 stituting therefor the words “fourteen hundred forty-five”.

5 Further amend said section by striking from paragraph  
6 two (2) line two (2) the words “eighteen hundred” and substi-  
7 tuting therefor the words “fifteen hundred thirty”.

8 Further amend said section by striking from paragraph  
9 three (3) line two (2) the words “nineteen hundred” and substi-  
10 tuting therefor the words “sixteen hundred fifteen”.

11 Further amend said section by striking from paragraph  
12 four (4) line two (2) the words “two thousand” and substituting

6 six (6) and seven (7) the words “three thousand” and substi-  
7 tuting therefor the words “twenty-four hundred”.

1 Sec. 10. (Compensation of Township Trustees) Amend section  
2 fifty-five hundred seventy-one (5571), code 1931, by striking  
3 from paragraph one (1) line three (3) the words “four dollars” and  
4 substituting therefor the words “three dollars”.

5 Further amend said section by striking from paragraph  
6 one (1) line six (6) the words “four dollars” and substituting  
7 therefor the words “three dollars”.

1 Sec. 11. (Compensation of Township Clerks) Amend section  
2 fifty-five hundred seventy-two (5572), code 1931, by striking  
3 from paragraph one (1) lines four (4) and five (5) the words  
4 “four dollars” and substituting therefor the words “three dollars”.

1 Sec. 12. (Compensation of Assessors) Amend section fifty-  
2 five hundred seventy-three (5573), code 1931, by striking from  
3 line six (6) the words “four Dollars” and substituting therefor  
4 the words “three dollars”.

5 Further amend said section by striking from line thirteen  
6 (13) the words “four dollars” and substituting therefor the words

7 "three dollars".

1 Sec. 13. (Compensation of Assessors and Deputies) Amend  
2 section fifty-six hundred sixty-nine (5669), code 1931, by strik-  
3 ing from line nine (9) the words "eighteen hundred" and substi-  
4 tuting therefor the words "fifteen hundred thirty".

5 Further amend said section by striking from line eleven  
6 (11) the words "eighteen hundred" and substituting therefor the  
7 words "fifteen hundred thirty".

8 Further amend said section by striking from line twelve  
9 (12) the word "five" and substituting therefor the word "four".

10 Further amend said section by striking from line fifteen  
11 (15) the word "five" and substituting therefor the word "four";  
12 and by striking from lines fifteen (15) and sixteen (16) the words  
13 "and fifty cents".

14 Further amend said section by striking from lines twenty-  
15 four (24) and twenty-five (25), the words "twenty-five hundred"  
16 and substituting therefor the words "two thousand sixty-three".

17 Further amend said section by striking from line twenty-  
18 seven (27) the words "eighteen hundred" and substituting there-  
19 for the words "fifteen hundred thirty".

1 Sec. 14. That all statutory salaries of county and township  
2 officers shall be reduced as follows:

3 All salary rates of nine hundred ninety nine (\$999) dollars  
4 per year and under shall be reduced five (5) per cent.

5 All salary rates of one thousand (\$1000) dollars to fourteen  
6 hundred ninety-nine (\$1499) dollars per year inclusive shall be

7 reduced ten (10) per cent but not less than nine hundred fifty  
8 (\$950) dollars per year.

9 All salary rates of fifteen hundred (\$1500) dollars to  
10 nineteen hundred ninety-nine (\$1999) dollars per year inclusive  
11 shall be reduced fifteen (15) per cent but not less than thir-  
12 teen hundred fifty (\$1350) dollars per year.

13 All salary rates of two thousand (\$2000) dollars to twenty-  
14 four hundred ninety-nine (\$2499) dollars per year inclusive shall  
15 be reduced seventeen and one-half (17½) per cent but not less  
16 than seventeen hundred (\$1700) dollars per year.

17 All salary rates of twenty-five hundred (\$2500) dollars to  
18 twenty-nine hundred ninety-nine (\$2999) dollars per year inclusive  
19 shall be reduced twenty (20) per cent but not less than two thou-  
20 sand sixty-three (\$2063) dollars per year.

21 All salary rates of three thousand (\$3000) dollars to thirty-  
22 four hundred ninety-nine (\$3499) dollars per year inclusive shall  
23 be reduced twenty-two and one-half (22½) per cent but not less  
24 than twenty-four hundred (\$2400) dollars per year.

25 All salary rates of thirty-five hundred (\$3500) dollars to  
26 thirty-nine hundred ninety-nine (\$3999) dollars per year inclusive  
27 shall be reduced twenty-five (25) per cent but not less than  
28 twenty-seven hundred thirteen (\$2713) dollars per year.

29 All salary rates of four thousand (\$4000) dollars per year  
30 or over shall be reduced twenty-seven and one-half (27½) per cent  
31 but not less than three thousand (\$3000) dollars per year.

1 Sec. 15. That nothing herein contained shall be construed

2 as changing the salaries of elected public officials who, under  
3 the Constitution or the laws of this state, are entitled to re-  
4 ceive their present salaries during the term for which they are  
5 elected.

1 Sec. 16. That all provisions of the code 1931 and laws of  
2 the Forty-fourth (44th) General Assembly, relating to salaries be  
3 amended, revised and codified in accordance herewith.

1 Sec. 17. All acts or parts of acts in conflict with the  
2 provisions hereof are hereby repealed.
