Reducing statutory salaries of county officers.

A BILL FOR

An Act to amend sections fifty-one hundred twenty-five (5125), fifty-two hundred twenty (5220), fifty-two hundred twenty-one (5221), fifty-two hundred twenty-two (5222), fifty-two hundred twenty-three (5223), fifty-two hundred twenty-four (5224), fifty-two hundred twenty-five (5225), fifty-two hundred twenty-six (5226), fifty-two hundred twenty-seven (5227), fifty-two hundred twenty-eight (5228), fifty-two hundred twenty-nine (5229), fifty-two hundred thirty (5230), fifty-two hundred thirty-one (5231), fifty-two hundred thirty-two (5232), fifty-five hundred seventy-one (5571), fifty-five hundred seventy-two (5572), fifty-five hundred seventy-three (5573) and fifty-six hundred sixty-nine (5669), code 1931, to revise statutory salary rates of county officers, their deputies and clerks.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. (Supervisors.) Amend section fifty-one hundred
2 twenty-five (5125), code 1931, by striking from line three (3)
3 the word "five" and substituting therefor the word "four."

4 Further amend said section by striking from line four
5 (4) the word "five" and substituting therefor the word "four."

1 Sec. 2. (County Auditor.) Amend section fifty-two hundred
2 twenty (5220), code 1931, by striking from paragraph one (1),
3 line one (1), the words "seventeen hundred" and substituting
4 therefor the words "one thousand five hundred thirty."

5 Further amend said section by striking from paragraph
6 two (2) line two (2) the words "eighteen hundred" and substituting
7 therefor the words "one thousand six hundred twenty"

8 Further amend said section by striking from paragraph

9 three (3), line two (2), the words “nineteen hundred” and sub-
10 stituting therefor the words “one thousand seven hundred ten”

11 Further amend said section by striking from paragraph

2 five hundred seventy-three (5573), code 1931, by striking from
3 line six (6), the words “four dollars” and substituting therefor
4 the words “three dollars.”

6 (13), the words “four dollars” and substituting therefor the words
7 “three dollars.”

1 Sec. 18. (Compensation of Assessors and Deputies.) Amend
2 section fifty-six hundred sixty-nine (5669), code 1931, by strik-
3 ing from line nine (9) the words “eighteen hundred” and sub-

4 stituting therefor the words “one thousand six hundred twenty.”

5 Further amend said section by striking from line eleven

6 (11) the words “eighteen hundred” and substituting therefor the

7 words “one thousand six hundred twenty.”

8 Further amend said section by striking from line twelve

9 (12) the word “five” and substituting therefor the word “four.”

10 Further amend said section by striking from line fifteen

11 (15) the word “five” and substituting therefor the word “four;”

12 and by striking from lines fifteen (15) and sixteen (16) the words

13 “and fifty cents.”

14 Further amend said section by striking from lines twenty-

15 four (24) and twenty-five (25), the words “twenty-five hundred”

16 and substituting therefor the words “two thousand one hundred

17 twenty-five.”

18 Further amend said section by striking from line twenty-

19 seven (27) the words “eighteen hundred” and substituting there-

20 for the words “one thousand six hundred twenty.”

1 Sec. 19. That all statutory salaries be reduced as follows:

2 All salary rates of one thousand dollars (\$1,000) per year

3 and under shall be reduced five (5) per cent.

4 All salary rates of one thousand one dollar (\$1,001) per

5 year and less than one thousand five hundred and one dollars

6 (\$1,501) per year shall be reduced seven and one-half (7½) per

7 cent but shall not be reduced to less than nine hundred sixty

8 dollars (\$960) per year.

9 All salary rates of one thousand five hundred and one

10 dollars (\$1,501) per year and less than two thousand and one
11 dollars (\$2,001) per year shall be reduced ten (10) per cent,
12 but shall not be reduced to less than one thousand four hun-
13 dred dollars (\$1,400) per year.

14 All salary rates of two thousand and one dollars (\$2,001)
15 per year and less than three thousand six hundred and one
16 dollars (\$3,601) per year shall be reduced fifteen (15) per cent
17 but shall not be reduced to less than one thousand eight hundred
18 thirty-five dollars (\$1,835) per year.

19 All salary rates of three thousand six hundred and one
20 dollars (\$3,601) per year and less than five thousand and one
21 dollars (\$5,001) per year shall be reduced twenty (20) per cent
22 but shall not be reduced to less than three thousand one hun-
23 dred dollars (\$3,100) per year.

24 All salary rates of five thousand and one dollar (\$5,001)
25 per year and over shall be reduced twenty-five (25) per cent,
26 but shall not be reduced to less than four thousand one hundred
27 dollars (\$4,100) per year.

1 Sec. 20. That all provisions of the code 1931 and laws of
2 the Forty-fourth (44th) General Assembly, relating to salaries be
3 amended, revised and codified in accordance herewith.

1 Sec. 21. All acts or parts of acts in conflict with the
2 provisions hereof are hereby repealed.
