

Reducing the statutory salaries of city officials.

A BILL FOR

An Act to amend sections sixty-five hundred seventeen (6517), sixty-seven hundred four (6704), sixty-seven hundred five (6705), sixty-nine hundred forty-three-c four (6943-c4), ten thousand six hundred eighty-eight (10,688), ten thousand seven hundred thirty-nine (10,739), and ten thousand seven hundred forty-eight (10,748), code 1931, to reduce statutory salaries for city officers.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. (Salaries of Mayor and Councilmen) Amend sec-
2 tion sixty-five hundred seventeen (6517), code 1931, by striking
3 from subsection one (1) line six (6) the words "one hundred
4 fifty dollars" and substituting therefor the words "one hun-
5 dred forty-two dollars and fifty cents".

6 Further amend said section, subsection one (1), by
7 striking from line ten (10) the words "one hundred twenty" and
8 substituting therefor the words "one hundred fourteen".

9 Further amend said section by striking from sub-
10 section one (1), line fourteen (14) the words "twenty-five
11 hundred" and substituting therefor the words "two thousand one
12 hundred twenty-five".

13 Further amend said section, subsection one (1), by
14 striking from line sixteen (16), the words "two thousand" and
15 substituting therefor the words "eighteen hundred".

16 Further amend said section, subsection two (2), by

17 striking from lines three (3) and four (4) the words “twenty-
18 five hundred” and substituting therefor the words “two thousand
19 one hundred twenty-five”.

20 Further amend said section, subsection two (2), by
21 striking from line five (5) the words “eighteen hundred” and
22 substituting therefor the words “one thousand six hundred twenty”

23 Further amend said section, subsection three (3),
24 by striking from line three (3) the words “three thousand” and
25 substituting therefor the words “two thousand five hundred
26 fifty”.

27 Further amend said section, subsection three (3),
28 by striking from lines four (4) and five (5) the words “twenty-
29 five hundred” and substituting therefor the words “two thou-
30 sand one hundred twenty-five”.

31 Further amend said section, subsection four (4) by
32 striking from line three (3) the words “thirty-five hundred”
33 and substituting therefor the words “two thousand nine hundred
34 seventy-five.”

35 Further amend said section, subsection four (4), by
36 striking from line four (4) the words “three thousand” and sub-
37 stituting therefor the words “two thousand five hundred fifty.”

1 Sec. 2. (Compensation of Aldermen, Special Cities) Amend
2 section sixty-seven hundred five (6705), code 1931, by striking
3 from line three (3) the words “two thousand five hundred” and
4 therefor the words “five hundred seventy.”

1 Sec. 3. (Compensation of Mayor, Special Cities) Amend

2 section sixty-seven hundred five (6705), code 1931, by striking
3 from line three (3) the words “two thousand five hundred” and
4 substituting therefor the words “two thousand one hundred twenty-
5 five.”

1 Sec. 4. (Compensation of Trustees in City Owned Public
2 Utilities) Amend section sixty-nine hundred forty-three-c four
3 (6943-c4), code 1931, by striking from lines two (2) and three
4 (3) the words “six hundred” and substituting therefor the
5 words “five hundred seventy.”

1 Sec. 5. (Salary of Judge of Municipal Courts) Amend sec-
2 tion ten thousand six hundred eighty-eight (10,688), code 1931,
3 by striking from line two (2) the words “three thousand” and sub-
4 stituting therefor the words “two thousand five hundred fifty.”

5 Further amend said section by striking from line four
6 (4) the words “three thousand four hundred” and substituting
7 therefor the words “two thousand eight hundred ninety”.

8 Further amend said section by striking from lines
9 six (6) and seven (7) the words “three thousand six hundred”
10 and substituting therefor the words “three thousand sixty”.

11 Further amend said section by striking from line ten
12 (10) the words “eighteen hundred” and substituting therefor the
13 words “one thousand six hundred twenty”.

14 Further amend said section by striking from lines
15 eleven (11) and twelve (12) the words “twenty-two hundred” and
16 substituting therefor the words “one thousand eight hundred
17 seventy”.

18 Further amend said section by striking from line four-
19 teen (14) the words “twenty-six hundred” and substituting there-
20 for the words “two thousand two hundred ten”.

21 Further amend said section by striking from line seven-
22 teen (17) the words “fifteen hundred” and substituting therefor
23 the words “fourteen hundred”.

24 Further amend said section by striking from lines eighteen
25 (18) and nineteen (19) the words “one thousand seven hundred
26 fifty” and substituting therefor the words “one thousand five
27 hundred seventy-five”.

28 Further amend said section by striking from lines
29 twenty (20) and twenty-one (21) the words “two thousand” and
30 substituting therefor the words “eighteen hundred”.

1 Sec. 6. (Salary of Judge of Superior Court) Amend section
2 ten thousand seven hundred thirty-nine (10,739), code 1931, by
3 striking from line three (3) the words “thirty-seven hundred
4 fifty” and substituting therefor the words “thirty-one hundred”.

1 Sec. 7. (Salary of Superior Court Judges) Amend section
2 ten thousand seven hundred forty-eight (10,748), code 1931, by
3 striking from line four (4) the words “two thousand” and sub-
4 stituting therefor the words “eighteen hundred”.

5 Further amend said section by striking from line seven
6 (7) the words “three thousand” and substituting therefor the
7 words “two thousand five hundred fifty”.

1 Sec. 8. That all statutory salaries be reduced as follows:

2 All salary rates of one thousand dollars (\$1,000) per year

3 and under shall be reduced five (5) per cent.

4 All salary rates of one thousand and one dollars (\$1,001)
5 per year and less than one thousand five hundred and one dollars
6 (\$1,501) per year shall be reduced seven and one-half (7½) per
7 cent but shall not be reduced to less than nine hundred sixty
8 dollars (\$960) per year.

9 All salary rates of one thousand five hundred and one dollars
10 (\$1,501) per year and less than two thousand one dollars (\$2,001)
11 per year shall be reduced ten (10) per cent, but shall not be
12 reduced to less than one thousand four hundred dollars (\$1,400)
13 per year.

14 All salary rates of two thousand and one dollars (\$2,001)
15 per year and less than three thousand six hundred and one dollar
16 (\$3,601) per year shall be reduced fifteen (15) per cent but
17 shall not be reduced to less than one thousand eight hundred
18 thirty-five dollars (\$1,835) per year.

19 All salary rates of three thousand six hundred and one
20 dollar (\$3,601) per year and less than five thousand and one
21 dollar (\$5,001) per year shall be reduced twenty (20) per cent,
22 but shall not be reduced to less than three thousand one hundred
23 dollars (\$3,100) per year.

24 All salary rates of five thousand one dollars (\$5,001)
25 per year and over shall be reduced twenty-five (25) per cent,
26 but shall not be reduced to less than four thousand one hundred
27 dollars (\$4100) per year.

1 Sec. 9. That all provisions of the code 1931 and laws of

2 the Forty-fourth (44) General Assembly, relating to salaries be
3 amended, revised and codified in accordance herewith.

1 Sec. 10. All acts or parts of acts in conflict with the
2 provisions hereof are hereby repealed.

2 1931, be amended by striking out after the comma (,) in line
3 eleven (11), thereof the remainder of said line and lines twelve
4 (12), and thirteen (13).

1 Sec. 4. That section forty-three hundred fifty-six (4356),
2 code 1931, be amended by striking out the word “four” in line
3 three (3), and substituting therefor the word “two”.

1 Sec. 5. That section forty-four hundred fifty-one (4451),
2 code 1931, be amended by striking out the word “three” in line
3 six (6) and substituting therefor the word “two”.

1 Sec. 6. That section forty-four hundred seventy-three
2 (4473), code 1931, be amended by striking out the word “four” in
3 line eleven (11), and substituting therefor the word “two”.

1 Sec. 7. That section forty-six hundred eighty (4680), code
2 1931, be amended by striking out the word “four” in line two (2),
3 and substituting therefor the word “two”; and by striking out the
4 word “three” in line three (3) and substituting therefor the word
5 “two”; and by striking out the word “three” in line six (6), and
6 substituting therefor the word “two”.

1 Sec. 8. That section fifty-one hundred thirty-one (5131),
2 code 1931, be amended by striking out the word “four” in line six
3 (6) and substituting therefor the word “two”.

1 Sec. 9. That section fifty-three hundred ninety-eight (5398),
2 code 1931, be amended by striking out all of said section follow-
3 ing the period (.) in line four (4) thereof.

1 Sec. 10. That section fifty-three hundred forty (5340),
2 code 1931, be amended by striking out the words “, publish in

3 the official papers of the County as part of its proceedings,”
4 and substituting therefor the word “make”.

1 Sec. 11. That section fifty-three hundred ninety-nine (5399),
2 code 1931, be amended by striking out the remainder of said sec-
3 tion after the words “shall be” in line two (2) and substituting
4 therefor the words “two in all counties regardless of popula-
5 tion.”

1 Sec. 12. That section fifty-four hundred two (5402), code
2 1931, be amended by inserting the word “all” preceding the word
3 “counties” in line four (4); and by striking from lines four (4)
4 and five (5) the words “in which two newspapers are to be se-
5 lected”; and by striking the remainder of said section after the
6 period (.) following the word “newspapers” in line eight (8).

1 Sec. 13. That section fifty-four hundred ten (5410), code
2 1931, be amended by inserting the word “the” preceding the word
3 “two” in line seventeen (17), and by striking out the remainder
4 of said section following the word “newspapers” in line eighteen
5 (18) thereof.

1 Sec. 14. That section fifty-four hundred sixty-one (5461),
2 code 1931, be amended by striking out the word “three” in line
3 four (4), and substituting therefor the word “one”.

1 Sec. 15. That section fifty-four hundred sixty-eight (5468),
2 code 1931, be amended by striking out the word “four” in line
3 eight (8) and substituting therefor the word “two”.

1 Sec. 16. That section fifty-five hundred thirty-three
2 (5533), code 1931, be amended by striking out the word and syl-

3 lable “by publica” in line two (2) and by striking out lines
4 three (3), four (4), five (5), six (6), seven (7), eight (8),
5 and the words “shall be given” in line nine (9).

1 Sec. 17. That section fifty-six hundred sixty-three (5663),
2 subsection fifteen (15), code 1931, be amended by striking out
3 the word “three” in line three (3), and substituting therefor the
4 word “two”.

1 Sec. 18. That section fifty-six hundred seventy-nine
2 (5679), code 1931, be amended by striking out the word “two” in
3 line two (2), and substituting therefor the word “one”; and by
4 striking out the words “in one” in line three (3) thereof; and
5 by striking out the word “other” in line four (4) and substitut-
6 ing therefor the word “newspaper”.

1 Sec. 19. That section six thousand seventy (6070), code
2 1931, be amended by striking out the word “four” in line four
3 (4), and substituting therefor the word “two”.

1 Sec. 20. That section sixty-one hundred forty-five (6145),
2 code 1931, be amended by striking out the word “three” in line
3 four (4) and substituting therefor the word “two”.

1 Sec. 21. That section sixty-two hundred forty-four (6244),
2 code 1931, be amended by striking out the word “four” in line
3 three (3), and substituting therefor the word “two”.

1 Sec. 22. That section sixty-three hundred four (6304), code
2 1931, be amended by striking out the word “four” in line four
3 (4), and substituting therefor the word “two”.

1 Sec. 23. That section sixty-four hundred ninety-nine

2 (6499), code 1931, be amended by striking out the word “three”
3 in line four (4), and the words “successive days” in line five
4 (5), and substituting therefor the words “one day”.

1 Sec. 24. That section sixty-five hundred eight (6508), code
2 1931, be amended by striking out all of said section after the
3 comma (,) in line four (4), and substituting therefor “and shall
4 report to the city council the result thereof.”

1 Sec. 25. That section sixty-five hundred eighty-four
2 (6584), code 1931, be amended by striking out the word “four” in
3 line twelve (12), and substituting therefor the word “two”.

1 Sec. 26. This act being deemed of immediate importance
2 shall be in full force and effect after its passage and publi-
3 cation in the, a newspaper published at,
4 Iowa, and in the, a newspaper published at
5, Iowa.
