

A BILL FOR

An Act to Legalize the Corporate Acts and Proceedings of Clinton, Davenport & Muscatine Railway Company of Davenport, Iowa, and to provide for the renewal and Extension of the Period of Corporate Existence and the Adoption of Renewal, Amended and Substituted Articles of Incorporation of said Clinton, Davenport & Muscatine Railway Company.

WHEREAS, the period of corporate existence of Clinton, Davenport & Muscatine Railway Company, organized under the laws of the State of Iowa with its principal place of business in the City of Davenport, Scott County, Iowa, expired on the first day of February, 1930, and through inadvertence the same was not renewed within the period prescribed by Statute; and

WHEREAS, the said Clinton, Davenport & Muscatine Railway Company continued thereafter to conduct its business and affairs as a corporation; and

WHEREAS, on the 29th day of March, 1933, at a special meeting of the stockholders of said corporation called for that purpose, the corporate period of said corporation was renewed for a period of Twenty (20) years from the date of its expiration, and said stockholders adopted certain Renewal, Amended and Substituted Articles of Incorporation; and

WHEREAS, on the 30th day of March, 1933, a Certificate evidencing the renewal of the corporate existence of said corporation and the adoption of Renewal, Amended and Substituted Articles of Incorporation was filed in the office of the Secretary of State of the State of Iowa, and provision duly made for the payment of the filing and recording fees provided by law.

Now, Therefore, Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. All proceedings had with respect to
- 2 the renewal of the corporate existence of Clinton,
- 3 Davenport & Muscatine Railway Company and the adoption
- 4 of Renewal, Amended and Substituted Articles of
- 5 Incorporation be and the same are hereby legalized and
- 6 shall have the same force and effect as if adopted

7 pursuant to law within the period prescribed by statute,
8 and shall be held and considered as a renewal and ex-
9 tension of the period of corporate existence of said
10 corporation, which expired February 1, 1930, and all of
11 the corporate acts and proceedings of said corporation
12 subsequent to February 1, 1930, including the proceedings
13 in connection with the renewal and extension of the
14 corporate existence of said corporation and the adoption
15 of Renewal, Amended and Substituted Articles of Incorpora-
16 tion, are hereby declared to be valid and legal and to
17 have the same force and effect as though said renewal and
18 extension of the corporate existence had been consummated
19 within the time prescribed by law.

20 The Secretary of State is hereby authorized and
21 directed to issue to said Clinton, Davenport & Muscatine
22 Railway Company a Certificate of Renewal of the Corporate
23 existence of said corporation, providing that the corporate
24 existence shall expire on the First day of February, 1950.
25 Nothing in this Act shall be deemed or construed to affect
26 pending litigation.

1 Sec. 2. This Act, being deemed of immediate
2 importance, shall take effect and be in force from
3 and after its publication in the Davenport Democrat
4 and Leader and in the Davenport Daily Times, news-
5 papers published in the City of Davenport, Scott
6 County, Iowa, without expense to the State.
